Moved by Donald Fraser seconded by Alexander McHardy that Robert McNeil be elected Warden of this Council, which on being first to the council was carried movement.

Mr. McNeil was duly sworn to discharge the duties of Warden for remainder of Term.

Moved by Councilor McColl, seconded by Councilor that the Warden elected do attend at the office of the late Warden in the County Building one day in each week for the performances of the duties of Warden for the County.

The Warden indicated that he did not see it practicable that any other matter should be brought up at this meeting other than that mentioned in and intimated by the requisition. Therefore moved by Councilor McColl seconded by Councilor McGillivray that the council do adjourn which motion being first to the Council do not proceed to transact any further business at this meeting but what is officially mentioned in the requisition which motion on being first to the Council was passed in the affirmation. Adjourned till 2 o'clock p.m.
