

MINUTES AND PROCEEDINGS
Of the
Municipal Council of Pictou Co.
JANUARY SESSION, 1888

First Day

January 10

Council met at 10 a.m. The Clerk called the roll and 19 councilors answered to their names. The Councilor elect for sec. 18, Neil Matheson, Esq., elected to fill the vacancy caused by the death of Alex Fraser, Esq., was then sworn in and signed to the roll.

The following Nominating Committee was appointed:

The Warden addressed the Council urging the advantage of getting promptly to work and so having a short session. He also stated that two claims had been made against the Municipality for damages alleged to have been caused by defective roads, and suggested that legislation be asked for to limit the liability of the county.

Moved by Clr. G.M. McKay, and seconded by Clr. James Kitchin, that no petitions or accounts be received in Council after Thursday the 12th inst. Carried.

Clr. J.D. Fraser thought the law should be changed so as to limit the liability of the county in cases of accident on roads. Clrs. McColl suggested the holding of a public meeting at which proposed changes in the laws might be discussed. Clr. G.M. McKay supported the views expressed by Clr. Fraser. On motion the Sheriff was instructed to grant the use of the Court House for a public meeting on Friday evening. Clrs. J.D. Fraser and Colin Fraser thought some amendments securing greater efficiency in the matter of statute labor would do much to prevent accidents on the roads. Clr. Dewar considered it impossible to prevent such accidents absolutely, and that the only remedy is to limit the liability of the county.

Clr. H.S. Fraser, chairman, read the following report of the Nominating Committee.

Committee on Nomination

Pictou, 10th January, 1888

On motion the report was adopted.

Clr. E.J. Ross moved, seconded by Clr. Meikle that a special committee be appointed for the purpose of investigating, and recommending such amendments to the laws respecting Roads and Bridges and Statute Labor, as may relieve the county of liability for damages for which the county is now responsible under the existing statute, and also to consider what action will be taken with cases now pending. Carried.

Some discussion took place respecting the publication of the minutes and list of officers. Moved by Clr. Kitchen, seconded by Clr. Geo. M. McKay, that the matter be dealt with the Finance Committee to be dealt with. Carried.

Clr. E.J. Ross suggested that a number of copies of the official oath be printed and sent to the councilors. Clr. Bell proposed that a committee on law amendments be appointed. After some discussion the motion already passed for a special committee to consider claims for accidents was amended by adding the words “and all other proposed law amendments.”

Clr. Kitchen referred to the land damages of the Short Line as run by the Great American and European Short Line Company. After some debate it was moved by Clr. Kitchen, seconded by Clr. Ross, that the Railway Committee of last year be continued, and that the matter of the Short Line damages be referred to it, to report this term. Passed.

On motion, the Council adjourned till 10 a.m. Wednesday.

Second Day

January 11

The Council met at 10 a.m. Minutes of the last meeting were read and adopted. The Warden read the Treasurer's statement for 1887. Mr. McColl thought too much was paid for jury fees and that some means should be adopted to restrict the amount.

The Warden read the endorsements of papers filed with the Clerk since last meeting and handed them to the proper committees.

The Petition of inhabitants of East River, St. Mary's, for a road from that place to James River station, on the Eastern Extension Railway, was read by the Warden, and after some discussion was referred to the Committee on Roads and Bridges.

The Warden read the petition of the Stewiacke Valley and Lansdowne Railway Company for aid in acquiring the right of way. On motion it was referred to the Railway Committee.

The Warden read the petition of the Pictou Coal and Iron Company for a subsidy; which was also on motion referred to the Railway Committee.

Moved by H.S. Fraser, and seconded by H.D. Denoon,

"That the bridge over West River at Loch Broom in the county of Pictou be placed under the provision of the Bridge Act." Carried.

The Warden read letters referring to claims against the county for damages sustained on roads. Referred to the special committee on road accidents and law amendments.

Moved by Clr. John D. Fraser and seconded by Clr. Robt. Dewar, "that the bridge spanning French River on the Piedmont Valley road; and the bridge on French River road near Fraser's old mill stand be placed under the Road and Bridge Act," Carried.

On motion, the Council adjourned until 2 p.m.

Afternoon Session

The Council met at 2 p.m. The Warden read the endorsements of papers filed with the clerk since last meeting, and handed them to the proper committees.

The Council on motion adjourned at 4 p.m. until 10 a.m. to morrow.

Third Day

January 12

The Council met at 10 a.m. The minutes of Wednesday afternoon were read and adopted. The Warden read the endorsements on papers filed with the Clerk since last meeting and handed them to the proper committees.

The Warden read the petition of John Stewart, bridge builder, New Glasgow, for relief for losses caused by a storm while erecting the iron bridge at New Glasgow.

Moved by Clr. McColl, seconded by Clr. Donald Fraser, that,

"Whereas John Stewart of New Glasgow, the contractor for building the iron bridge over the East River at New Glasgow, has applied to this council to be reimbursed for the cost of repairing this bridge, which repairs were necessitated by an accident caused by an extremely heavy gale of wind which could not have been foreseen when the contract was taken by him; and whereas the Provincial Government have the expenditure of the money's expended under the Bridge Bill;"

Therefore resolved that this Council would respectfully bring the matter to the notice of the Provincial Government and recommend them to allow Ms. Stewart such compensation as the Provincial engineer may think he is entitled to for the damage, not exceeding the sum of five hundred and fifty dollars."

Clr. G.M. McKay did not see what the council had to do with the matter. Clr. Dewar supported the motion, as also did Clr. Donald Fraser who thought the government ought to allow a reasonable sum for the loss and charge it to the county. Mr. McColl stated that even if \$550 were granted to Mr. Stewart, the county would still be better off by about \$2000 than if he had not tendered. This view was supported by Clrs R. McDougall and J.D. Fraser. Clr. Bell pointed out that Mr. Stewart's operations had been of great benefit to the county in reducing the cost of iron bridges, and that the accident was partly due to the fact that his work had been protracted into the stormy season by delay in the completion of the substructure, which was built under the supervision of the provincial engineer. Clr. G.M. McKay thought Mr. Stewart's remedy was by petition to the local government, and that this council had nothing to do with the case. Clr. McPherson asked why the substructure of the bridge had not been built under tender and contract. Clrs. James McKay and H.D. Denoon did not see what the council had to do with the matter. The motion was then put by the Warden and passed.

Clr. H.S. Fraser read a report of the Nominating Committee as follows:

Committee on Nominations, Pictou, 11th, January, 1888

On motion the report was received and adopted. On motion the Council adjourned until 2 p.m.

Afternoon Session

Council met at 2 p.m. The minutes of the forenoon meeting were read and adopted. The Warden read the endorsements on papers filed with the Clerk since the forenoon meeting and handed them to the proper committees.

Clr. J.R. McDonald called attention to the fact that in Sec. 6 there is no Justice of the Peace willing or compellable to distribute Statute Labor Lists without compensations. The Warden thought the law should be changed so as to enable Councilors to distribute the lists. After some discussion, the matter was deferred until the Nominating Committee should bring in its Report.

Clr. E.J. Ross proposed that the minutes of the May meeting be published in the same pamphlet with the January, minutes of the ensuing year. The question was referred to the consideration of the Finance Committee.

On motion the Council adjourned until 10 a.m. on Friday.

Fourth Day

January 13th

Council met at 10 a.m. The minutes of last meeting were read and adopted.

The Warden read the memorial of Wm. McDonald, Sec. 10, which was referred to the Assessment Committee.

The Warden called attention to the advisability of taking steps to induce the Government of the Dominion to repay the amount paid for Eastern Extension Railway Right of Way, and some discussion took place in the Council.

The members of the Council then engaged in Committee work until noon.

On motion the Council adjourned until 2 p.m.

Afternoon Session

The Council met at 2 p.m. The minutes of the forenoon meeting were read and adopted.

The Warden referred to Sec. 18 of Chap. 102 of the Revised Statutes, requiring a statement of summary convictions to be published and posted up by the Clerk.

Clr. Kitchin brought up the question of Collectors' Bonds in connection with one of the Rolls for 1886, which shows a deficiency of about \$200. The Clerk was instructed to prepare a by-law regulating the matter of Collectors Bonds, to be proposed at next meeting. Some discussion took place upon the loss the County sustained by the occasional appointments of inefficient Collectors. Clr. D.D. McLeod considered it the duty of Councilors to see to it that proper Township officers were appointed. On motion the Council adjourned at 4 o'clock until 10 a.m. on Saturday.

Fifth Day

January 14

The Council met at 10 a.m. The Warden read a memorial from New Glasgow respecting the Town Pump, and referred to the committee on Public Property.

The Warden read the by-law mentioned in yesterday's minutes. On motion of Clr. Kitchin, seconded by Clr. Grant, the by law was adopted.

The Warden read the report of the Commissioners of the Pictou County Asylum for 1887. On motion the Report was referred to the Finance Committee. The subject of the disposal of property belonging to patients at the Asylum was brought up by the Warden. Clr. J.D. Fraser thought a very slight change in the law would suffice. The matter was referred to the Committee on Law Amendments. The question of auditing the Asylum accounts was discussed for some time. Clr. Bell thought the auditors were unnecessary. Clr. McDougall thought that work of the auditors could not be dispensed with.

Clr. McColl moved, seconded by Clr. A. McKenzie, that

“Whereas this County has been for some years paying and there is still a large amount due, for the right of way for the Eastern Extension Railway, which latter amount, although the proprietors have been paid, is still a liability of the County Debentures have been issued for the same;

And whereas the Dominion Government have become the proprietors of this Railway and it is part of the Intercolonial

And whereas in all other cases of Government Railways in the Dominion it is the policy of the Dominion Government to pay the cost of the Right of Way:

Therefore resolved, that the members of the County in the Dominion Parliament be requested to represent our case to the Dominion Government and request that Government to refund to this County such amounts as we have paid for that purpose and also assume the balance that this County is responsible for.”

Clr. McKenzie thought that since nothing could be got without trying, the resolution should be passed. After some further debate the resolution was put and carried unanimously.

Moved by Clr. John Rod. McDonald, seconded by Clr. Kitchin and resolved that the Bridge on Black River, near Plainfield be put under operation of the Bridge Act.

Moved by Clr. John McPherson, seconded by Clr. Bell and resolved that the Bridge crossing McLellan's Brook at Fraser's Fulling Mills, be placed under the provisions of the Bridge Act.

On motion the Council adjourned until 2 p.m. on Monday.

Sixth Day

January 16

Council met at 2 p.m. The minutes of last meeting were read and adopted.

Moved by Clr. McKenzie seconded by A.J. McKay and resolved that the Bridge at David Langille's, at River John, be placed under the provisions of the Bridge Act.

The Warden called attention to the cost of the Asylum farm. Clr. D. Fraser thought it was unwise to continue farming if it was done at a loss.

A memorial of F.W. McKenzie, respecting the account of the Commissioners of Public Property at New Glasgow for 1886 was read. Clr. Bell did not see how the council could do anything to settle the matter. Clr. R. McDougall thought it was a dispute between W.F. McKenzie and J.C. Reid and should be settled by themselves. Clr. McPherson agreed in this opinion. Clr. D. Fraser said the commissioners were the servants of the Council, and it was the duty of the Council to see that justice was done. Clr. Bell said the Clerk might be authorized to write to Reid stating the substance of the memorial and asking explanations. This suggestion was agreed to.

Moved by Clr. H.S. Fraser, seconded by Clr. Colin Fraser and
"Resolved, that the Durham Bridge across the West River, in Polling Section No. 8 of Pictou County, be placed under the provisions of the Bridge Act."

Moved by Clr. H.S. Fraser, seconded by Clr. Colin Fraser and,
Resolved, that the Ten Mile Bridge across the West River in Polling section No. 8 of Pictou County, be placed under the provisions of the Bridge Act."

The Warden thought a limit should be put to the placing of bridges under the Bridge Act. Clr. James McKay suggested that no bridge be placed under the Act without a report from the Supervisor for the district, recommending such action. Clr. Ross thought the suggestion a good one, and that some hung should be done. Clr. Denoon said the bridges just asked for in Sec. 8 were very important, and ought to be under the Act. Clr. J.R. McDonald said the Bridge over Black River had been recommended by the Supervisor. Clr. Meikle thought the supervisor should recommend in all cases. Clr. Colin Fraser said no bridges in Section 9 had been built under the act and it would be unfair to stop now, but there would be no objections to the Supervisor being required to report. Clr. Geo. Sutherland said there were no bridges under the Act in Sec. 10, but thought a supervisor's report in each case would be an improvement.

Clr. McColl read the report of the majority of the Committee on Highway Labor, as follows: -

REPORT OF COMMITTEE ON HIGHWAY LABOR

Your Committee on Statute Labour beg leave to report;

1. That they have examined the returns of the Surveyors of Highways and Limits submitted to them, and would again recommend that surveyors when they are in doubt as to how they should be filled up should apply to the Councilor for the district for information.
2. Your Committee find the following returns wanting, and would recommend that if the same are not sent to the Clerk of the Municipality within 30 days from the rising of this Council, the Clerk proceed as the law directs against such surveyors, unless the Councilors of their district make satisfactory explanations in writing why these returns have not been made.

4. Your committee have had under consideration the Statute Labor Law (a). We would recommend that Sec. 4 of chapter 47 Rev. Stat., 5th series, be repealed.
(b) We would also recommend that all of Sec. 5 of said chap. Between the words “ferrymen” in the 4th line and “shall” in the 7th line be repealed.
(c) We would also recommend that Sec. 3 of the same chap. be amended so that it can be clearly understood, as follows: In 5th line of said Sec. “One hundred to two hundred dollars one day,” should be “One hundred to one hundred and ninety nine dollars one day,” and so on to the end of the Section.
(d) We would also recommend that Sec. 1 of the same chapter be repealed, as well Sec. 7 of the same chapter.

January 17

Council met at 10 a.m. Minutes of last meeting were read and adopted.

Clr. McColl read the report of the Committee on Poor, as follows:

2. Your Committee would recommend that the following order be passed : - *Ordered*, that the Overseers of Poor for Polling Section No. 24, pay to the Clerk and Treasurer of Overseers of Polling Section No. 21, thirteen dollars for the support of old paupers, said sum to be paid to said Clerk and Treasurer on or before the 1st day of December, 1888.
3. Your Committee would again recommend that Councilors would examine the accounts of the Overseers of Poor of their districts for the past year before they are sent to the Clerk, and have them in such a shape that there will be no trouble at the May meeting.
4. Your Committee would recommend that the question of making the Municipality a Poor Section, be brought to the notice of the ratepayers at the election of Councilors in November next.

Committee

On motion the Report was received. On motion, after some discussion, the Report was adopted.

The Report of the Committee on Highway Labor was then taken up, and on motion it was received and ordered to be read clause by clause. (The report will be found in yesterday’s minutes.)

On the motion to adopt the clause recommending the repeal of Sec. 4 of the Highway Labor Act, Clr. George M. McKay moved in amendment, seconded by Clr. Dewar, that the clause be struck out. Clrs. James McKay and Neil Matheson opposed the amendment. Clr. Denoon thought the law correct as it is. Clr. J.D. Fraser thought a change proposed. The proper amendment would be one compelling the young men to perform the full amount of their labor. Clrs. Grant supported the amendment. Clr. McPherson said that a more desirable reform would be clause securing that the commutation money be expended to better advantage than at present. Clr. Sutherland said the law elsewhere provided for the immunity of old men who are infirm, and that was enough. Clrs. Matheson and Kitchin sustained the

Committee's report. On motion, the amendment was defeated by a vote of 11 – 8. The clause then passed by a vote of 12 – 8.

On the clause asking for an amendment in Sec. 5 of the same Act, Clr. J.D. Fraser said the exception relating to clergymen and ordained ministers should be retained. Clr. Bell thought firemen also should be exempted. Clr. D.D. McLeod pointed out instances where the exemption of firemen had led to abuse. On motion the clause passed. All the remaining clauses passed and on motion the report as a whole was adopted.

The Warden read the memorial of the Pictou Ferry Coy., asking for a subsidy of \$300 a year for ten years. On motion it was decided to hear representatives of the memorialists. Mr. John U. Ross, Barrister, then addressed the Council in the interests of the Co. Clr. Geo. M. McKay thought the matter should be deferred until the close of the Session. A motion to defer was made by Clr. J.D. Fraser, seconded by Clr. Dewar. Clr. D. Fraser moved in amendment, seconded by Clr. Grant, that the memorial be referred to the Committee on Finance. Clr. Bell suggested that a sum might be voted, not appropriated to any particular Co., but to be given to the Co doing the work most satisfactorily. Clr. McColl said there ought to be petitions from the ratepayers of the different districts affected, asking for the subsidy. Clr. D. Fraser said the County had been assisting ferries across the harbour for 80 years, and he saw no reason why the most efficient ferry yet proposed should not be assisted. The motion to refer the matter to the Finance Committee was carried.

Clr. J. Rod McDonald presented the report of the Committee on Roads and Bridges. On motion it was received and ordered to be laid on the table until the afternoon session – then to be read clause by clause.

On motion the council adjourned until 2 p.m.

Afternoon Session

Council met at 2 p.m.

The minutes of the forenoon meeting was read and adopted.

The Report of the Committee on Roads and Bridges was then taken up, read clause by clause, and passed as follows:

JANUARY 18

Council met at 10 a.m. The minutes of last meeting were read and adopted.

Clr. McColl pointed out what he considered to be some defects in the special act passed in 1886, to enable the Council to make an assessment to pay for the right away for the Pictou Town branch railway. After some debate, on motion of Clr. D. Fraser, the Clerk was instructed to write to the members for the county in the Local Legislature during the coming session to press for an amendment of the Act, if such should be required.

The Report of the Committee on Road accidents and law amendments was read as follows:

REPORT OF COMMITTEE ON ROAD ACCIDENTS AND LAW AMENDMENTS
MUNICIPAL COUNCIL

January Term, 1888

To the Warden and Municipal Council of Pictou County

The Committee appointed to report on certain claims against the county for accidents on the highways and also to report what amendments are unnecessary to the Statutes of the province and bye-laws of the Municipality beg leave to report.

1st. The claim of Mrs. Dan Stewart for an accident at or near the crossing at Thos. Horn's Middle River. We recommend the Council not to acknowledge any liability.

2nd. The claim of John Arbuckle for the sum of \$3000 for an accident at or near Alma, Middle River. We also recommend the Council not to acknowledge any liability.

3rd. In reference to amendments to the Statutes of the provinces, your Committee think that it was the intention when the County Incorporation Act was passed, that all matters connected with county affairs should be incorporated in that Act, such as the Municipal Assessment act, the Poor Act, the Statute Labor Act, as well as the acts relating to fire wards, and the Municipal Council be given power to make bye-laws in accordance therewith, such bye-laws to be confirmed by the Governor in Council and thus become law.

4th. Pending this being done your committee recommend that the legislature be applied to, to have the following acts amended as follows:

(a) *Chap. 16, Rev. Stat. to be amended as follows:*

1. The Municipalities shall in no case be liable for damages for accidents that may occur by trucking, riding, driving or walking on the highway except neglect can be shown on the part of the official required to keep the highway or bridge in repair.

2. When a supervisor has been appointed to expend the provincial road grant under this Chapter, upon written notice being given to such supervisor that a bridge is broken down or unsafe or the road damaged is unsafe, he shall, upon the written order of a Councilor of his road board forthwith proceed to cause the necessary repairs.

3. Surveyors of highways appointed by the Council to discharge the duties required by chap. 47, fifth series, upon written notice by a rate payer that a bridge is broken, or the highway is dangerous or impassable, shall apply to a councilor of the road board who shall grant the said surveyor an order to forthwith proceed to cause the necessary repairs, which shall be his

sufficient authority to order all persons liable to perform statute labor to work with the necessary implements and teams in order that the same may be rendered passable and safe, and every person so liable not complying with the order shall for every omission forfeit one dollar, but no person shall be obliged to furnish more days labor than he was liable to perform in the term previous to such order. Surveyors of Highways refusing to comply with such order of the council shall be liable for one half of the damages caused by delay, such liability not to exceed forty dollars.

(b) Chap. 47, Rev. Stat. to be amended as follows:

1. Brushwood overhanging highways, or trees falling on or leaning over the highways, shall be removed by the surveyor of highways when brought to his notice in the same way, provided he thinks the same necessary.

2. The expenditure of the commutation money should be guarded by another clause as follows: "No surveyor of highways shall employ in the expenditure of commutation money any person who during the year may have commuted the statute labor which he was liable to perform under the said surveyor, with the consent of the road supervisor in writing, which shall be returned with the road returns,"

(c) Your Committee recommend that Chap. 44, Rev Stat. be amended by adding the following clause:

1. When highways and bridges become dangerous and there is no money or labor to repair them they should be closed by the supervisor of the District and when so done parties traveling on them shall do so at their own risk.

(d) Your Committee recommend that Sec. 11, Chap. 44 of the Acts of 1886, be amended by providing for the renting or disposal of lands belonging to insane inmates of the county asylum.

(e) Your Committee recommend that the following changes be made in Chap. 56, Rev. Stat. and amending acts.

1. That the Council have power to define the duties of auditors, and may by bye-laws direct them to audit the accounts before the annual meeting of the Council so that their report may be ready on the first day of the annual meeting.

2. That the oath of officers of the Municipality be of a shorter and more concise nature.

3. That it be imperative in each Municipality that a deputy warden be appointed.

All of which is respectfully submitted.

McKay, and J.D. Fraser opposed the motion; which was supported by Clrs. James McKay, Matheson and Denoon. Clr. Bell said the motion was opposed to the whole tendency of enlightened legislation; and that the former state of affairs was unjust to debtors outside of the town of Pictou. The motion was lost on division by a vote of 11 to 8.

Clr. Kitchin read the report of the Committee to meet the town Councils of Pictou and New Glasgow and settle the apportionment of assessments for 1888. On motion the report was received and laid on the table until the afternoon.

Clr. Bell read the report of the Committee on Finance. On motion the report was received and laid on the table until the afternoon.

On motion the Council adjourned until 2 p.m.

On the clause recommending that the Provincial Asylum account for interest not paid, Mr. Bell explained that this charge was for interest upon old arrears which were really paid off at the beginning of 1887, and should have been then struck off by the Commissioners; and also for interest upon the quarterly balances upon which, in the opinion of the committee, the government is not entitled to claim interest.

On the estimate for Reviser's fees for 1888, Mr. Bell stated that a memorial had been received from one of the Revisers for sections 12, 13, and 14, complaining that the Revisers for that district were not sufficiently remunerated; but the committee had come to the conclusion that no increase could fairly be made in one district without increasing the fees in all other districts.

On motion the Report was adopted.

The Supplementary Report of the Finance Committee on the petition of the Pictou Ferry Company was read by the Warden as follows: -

SUPPLEMENTARY REPORT OF FINANCE COMMITTEE

The Finance Committee after considering the petition of Joseph A. Gordon representing a Ferry Company, and asking for a grant of \$300 per year for 10 years in aid of a steam ferry proposed to be maintained on Pictou Harbor, beg leave to report as follows: -

Moved by Clr. McColl, seconded by J.D. Fraser, that the Report be not adopted, on the ground that the Council has no power to grant a subsidy for more than one year. Clr. D. Fraser thought the Report should be adopted, because the proposed ferry was for general advantage of the County, and in line with the action of the old Sessions and this Council for generations. Moved in amendment by Clr. Kitchin, seconded by Clr. Grant that the report be received and adopted. The amendment was supported by Clr. Matheson, who was of the opinion that those sections which had been deprived of the use of the Railway Ferry should be relieved. Clr. Colin Fraser considered the amount small for so an object. Clr. J. D. Fraser said the granting of such a subsidy was illegal. Clr. McColl said there was no use in passing the resolution as it would not bind next Council, and would have to come back every year. Clr. Dewar thought the granting of the petition might prejudice the efforts of the people of Fisher's Grant to secure regular railway communication with New Glasgow. Clr. D. Fraser said the people of Fisher's Grant and other districts were practically unanimous in desiring the ferry. The Warden pointed out that legislation would not be required, but need not be asked for until the Company is in operation. Clr McKenzie said that was all the memorial asked, and the Committee recommended. The amendment was carried on division and the report adopted.

11th The appeal of Angus McInnis of Section No. 7. for a refund of taxes. We recommend that the prayer of his petition be granted and the Treasurer be ordered to refund the sum of \$3.68.

12th The appeal of Daniel McNeil of Section No. 23 for a refund of taxes. We recommend that the payer of the petition be granted and the Treasurer be ordered to refund the sum of \$3.98.

13th The appeal of Jas. W. Murray, Jr. of Section No. 20 for a refund of taxes; we recommend that the payer of the petition be granted and that the Treasurer be ordered to refund the sum of \$2.40.

14th The appeal of Ambrose Manning of Section No. 24 for a refund of taxes; we recommend that the payer of his petition be granted and that the Treasurer be ordered to refund the sum of \$1.10.

15th The petition of Alex McMillan of Section No. 16 for a refund of taxes for the year 1885 on account of his mills having been destroyed by fire in said year; dismissed as we consider that he has already been sufficiently relieved, having been exempted from taxation for the year 1886.

16th The appeal of John Hoar of Stellarton, Section No. 25, for the refund of taxes; dismissed for further information.

17th The appeal of James W. Flockhart of Section No. 21 for a refund of taxes; we recommend that the prayer of his petition be granted and the Treasurer be ordered to refund the sum of four dollars and eighty cents.

18th The appeal of Jas. A. Robertson of New Glasgow for a refund of taxes; dismissed, not being sworn to.

Your Committee would recommend that the Clerk be ordered to carry out our recommendations of last year in connection with the printed instructions which should accompany Collector's Rolls.

Your Committee would also recommend that it be brought to the notice of the Councilors that they would use their influence to have the most competent and reliable men appointed for Collectors in several Sections, as we find them the Rolls and returns as received from Collectors that a great many of them are in a very imperfect and unsatisfactory condition.

Clr. Weir read the Report of the Committee on Public Property, as follows: -

REPORT OF COMMITTEE ON PUBLIC PROPERTY

To the Warden and Municipal Council, January Term, 1888

Your Committee on Public Property be leave to report as follows: -

1. Your Committee made the usual inspection of the Old Court House and Jail, and are glad to report the same in good order, and that the keeper of the jail deserves much credit for his diligence and painstaking in keeping the Old Court House and grounds in good order, as well as the ease and comfort extended to the persons under his care.

2. Your Committee are much pleased to find that their suggestions and recommendations in January have been attended to. With respect to the repairs on the New Court House, we are of the opinion that the Commissioners of the Court House have discharged their duty well, and that they deserve the thanks of the Council for the economical manner in which the work has been done. The closing of the gallery has improved the sound of the building very much, and the painting of the interior adds very much the appearance of the building, which makes it look almost new, and we may say on the whole, reflects credit on the County, and at the moderate expense of \$125.75.
3. Our attention has been drawn to the Market platform, which is in a very bad condition. The keeper of the Market says if the Council supply the plank that he will do the work free of charge. In this case your Committee would recommend the expenditure of a few dollars in order to keep the public from accidents and the County from damages.
4. The Report of the Commissioners of Public Property in New Glasgow was laid before us, from which we gather the following: (1) that the Commissioners found it necessary to repair one of the cells of the jail at a cost of about \$30, also some other repairs, as will be seen by the bill rendered by the jailer; and we find that other repairs are wanted in the immediate future, and that it will require considerable expenditure. Your committee would recommend that the Commissioners of the Court House be authorized to expend such a sum as in their opinion will be necessary for the protection of the Court House and jail and the safety of the inmates, with due regard to economy.
5. We also find the Town Council has expended quite a large sum in repairing the Market building, which will protect the building from decay for many years to come.

A number of complaints by petition and otherwise, from the rate able inhabitants of New Glasgow and the country, setting forth that the Council have prevented them from getting water out of the public pump in the Market grounds, and refuse to keep it in order for the public use, and that the people from the country are put to very great inconvenience by their action. As to this complaint your Committee would recommend that the Clerk of the Council be instructed to notify the Town Council of New Glasgow that the country people must have the same privileges as they have heretofore enjoyed respecting water and access to the Market grounds and that in the event of the Town Council of New Glasgow not complying with this request, the lease with the Municipality will become null and void; and further that the Commissioners of Public grounds be instructed to see that the interests of the County are protected at all times, and the agreements carried out, and if they refuse to keep the present pump in order for the use of the public that they must furnish a suitable watering place from their present system of water works.

6. The report of the Supervisors of Public Property of the Township of Egerton for 1887 was before us, stating that they had complaints from seven different sections where the public roads had been encroached upon for the last year, but in all these cases except one, namely Daniel Campbell of McLellan's Brook, which is still unsettled, the Supervisors have settled with the parties, and had the obstructions removed.

7. Your Committee regret to find that their suggestions in their report of Jany, Term, 1887, repeating the encroachments on the public landing on Kempt Street have not been attended to. Therefore we would recommend that the Town Council and the Municipal Council take immediate action to have all obstructions removed and that the Clerk of the Council and the Warden be instructed to attend to the matter, and employ counsel if they find it necessary, to obtain a proper landing for the public, and the rights of the Municipality protected.
8. We were much pleased to find by the Report of the Commissioners of the Pictou County Asylum that that institution is in good order and well managed, and although the expenditure has been very large, yet it is very satisfactory to find that so far it has come up to the most sanguine expectations of its promoters, and the harmless insane are much cheaper kept and cared for then they were in the Provincial Asylum; and your Committee are of opinion that with judicious and economical management a still further saving might be effected. And whereas the Council has expressed a desire that your Committee would report as to their views respecting the County Asylum farm and the disposal of part of the same, your Committee would recommend that the matter be left in the hands of the Commissioners to do as they think best; but should purchaser offer a price satisfactory to them, we would recommend that the same be accepted, provided that a Committee of this Council, to be appointed for that purpose should approve of the same.
9. Your Committee on making their annual inspection of the jail, find that it would be advisable for the safety of the jailer to have a short partition and door placed at the entrance of the criminal room. Therefore your Committee would recommend the expenditure of a few dollars to have these improvements made.
10. Your Committee would recommend that the Public Record Building be put under the charge and care of the Commissioners of Public Property in the Town of Pictou; and further we would recommend that the Clerk of this Council be appointed one of the Commissioners, and that the Clerk will attend to and have all the public buildings insured in a good and first class office in the behalf of the Municipality.

The Running Expenses for 1887 have exceeded the estimate of the Commissioners owing to the transfer to the Asylum of an unexpected number of harmless insane from the Poor Districts, the poor rates being relieved in consequences to a corresponding extent.

It is estimated that not less then \$5,000 will be required for the running expenses of the County Asylum for 1888, (exclusive of amounts payable from poor Districts & c.)

REPORT OF RAILWAY COMMITTEE

JANUARY 19th, 1888

Your Committee have considered

1. The petition of the Pictou Coal and Iron Company asking for \$2000 per mile, not to exceed \$20,000, in aid of a proposed railway, from their Iron mines to the Intercolonial.
2. The petition of the Stewiacke Valley and Lansdowne Railway Co. asking for a grant of \$500 per mile not to exceed \$8000, in aid of their proposed railway, from the County line near Lansdowne toward Westville.
3. The consideration of the damages for right of way and station grounds for the Pictou Branch Railway, and the mode in which these may be dealt with by the Council.

In reference to the first mentioned matter, we beg leave to report that we cannot recommend that the prayer of the petition be granted.

In reference to the second matter, we report that we cannot recommend the aid in question

In references to damages for right of way and station grounds, your Committee report that in the course of the year, and since the last meeting of the Council, they met by request the Warden and Councilor McColl and John McDougald M.P. and after consultation passed the following resolution:

“We approve of the expenditure in Schedule A., attached to the report of the Railway Committee in 1887, and estimated expenditure in Schedule B, hereto attached. Any further expenditure in addition to the sums set forth in Schedules A & B aforesaid, to be subject to the approval of the Committee undersigned for said right of way and station grounds, not to exceed \$18,000 without the special order of the said County Committee.

This resolution was passed in consequence of the representation of the Pictou Railway Committee that the Merchants’ Bank would not take over their account without such action on the part of the Committee. At a later date your Committee again through arrangement met the Railway Committee, which asked authority to acquire the lands at a subsequent date purchased by the Railway Committee from Mr. John r. Noonan and the estate of the late W.H. Davies. Your Committee did not assent to the proposed purchase.

Your Committee find by communication form the Railway Committee that all necessary properties have been acquired and paid for except the following, which are herein set down with their estimated cost:

The amount paid by the Railway Committee per Schedule E attached is \$17,090.77 making a total of \$19,270.77.

By comparison we find that of the sums paid \$14,445.42 were within the Town of Pictou, and of the sums estimated \$2030, making a total within the Town of \$16,495.42. The balance of \$2775.35 represents amount paid and estimated beyond the limits of the Town of Pictou.

By extract from the Minutes of the Town Council of Pictou hereto attached and marked F., it appears that the said Town Council of Pictou hereto attached and marked F., it appears that the said Town Council agreed by resolution in the event of the County Council agreeing to provide for said right of way and Station grounds, the town of Pictou will pay the amount of cost of said right of way and Station grounds which may be apportioned on the Town by said Municipal Council and will in addition thereto pay the amount if any by which the land damages within the Town limits shall exceed six thousand dollars. And further resolved that the Town Council will take the necessary steps to carry the foregoing resolution into effect.

As the amount now owing in consequence of the operations of the Railway Committee is bearing interest at the rate of six per cent, your committee are of opinion that provision should be made to reduce the rate of interest on such parts of the said debt as are likely to fall upon the Municipality of the County of Pictou.

We therefore recommend that arrangements be at once made to issue debentures, and for that purpose that the Warden with a special Committee of three to be appointed by this Council be authorized to decide as to the amount for which debentures shall issue, and as to the form, duration, and rate of interest which such debentures shall bear, also to negotiate with the Town of Pictou to the mode in which they propose to discharge the obligation incurred by them by the resolution of Council herein cited, and to apply for such additional Legislation as may be required in order to discharge these duties.

We would suggest that the debentures to be issued should be discharged by annual payments of one thousand dollars in each of the years 1889, 1890, 1891, 1892; and the residue in equal annual installments as nearly as possible, the whole to be paid in ten years from the date of issue.

- II. That the said Subsidy be *Two Thousand Dollars* per mile of said railway (without a free right of way) but not exceeding in the whole sum of *Twenty Thousand Dollars* exclusive of any subsidy which the Town Councils of New Glasgow and Pictou may respectively agree to pay.
- III. That upon the opening of said railway for traffic the said subsidy shall be paid to the said company from the proceeds of bonds which shall be issued by the Municipality of Pictou County and falling due in twenty years from time to time of issue with interest at five per cent, per annum, payable yearly on the first day of December
- IV. That no subsidy shall be paid or bonds issued by the Municipality on an account of said railway unless the following conditions be complied with, that is to say
 - (a) That the said railway shall be constructed in a substantial manner, of a standard not inferior to the railway between New Glasgow and Thorburn, with a gauge of 4 feet 8 ½ inches.

- (b) That the said Company shall have bona fide expended not less than two hundred and fifty thousand dollars in constructing said railway or parts thereof and in Iron Smelting Works in the County of Pictou
- (c) That the said railway shall be open for traffic, and the said expenditure for such railway and Iron Smelting Works, made, and proof thereof furnished to the Municipal Council of Pictou County on or before the first day of July, A.D., 1890.

Moved by Clr. McColl, seconded by Clr. J.D. Fraser that the remainder of the report be adopted. Moved in amendment by Clr. Geo. M. McKay, seconded by Clr. Matheson, as follows:

Resolution

1. That Debentures not exceeding twenty thousand dollars in the whole be issued by the Municipality of Pictou County and signed by the Warden and Clerk thereof, under the provisions of chapter 106 of the Statutes of Nova Scotia for 1886, to pay the land damages for the right of way and Station grounds for the extension of the Intercolonial Railway from a point at or near Stellarton.
2. That such debentures be payable in installments with five per cent interest, annually on the 30th day of November, as follows, that is to say:-

An installment of one thousand dollars per year and interest in each of the years 1889, 1890, 1891, 1892 and 1893; and an installment of three thousand dollars per year and interest in each of the years 1894, 1895, 1896, 1897 and 1898.”

On motion of Clr. Bell, seconded by Clr. Kitchin, the following Resolution respecting the damages on the Short Line was passed.

“Whereas the change of route determined on by the Dominion Government since talking over the Short Line Railway has left certain damages to property in the County of Pictou unprovided for; therefore resolved that in the opinion of this Council the payment of these damages would fairly fall upon the Dominion Government:

Further resolved that a copy of this Resolution be brought to the notice of the Dominion Department of Railways by our Dominion Representatives.”

The Committee on Finance reported verbally that the printing of the Minutes of this meeting and of the May meeting 1887, had been awarded to Albert Dennis at the price of \$60, and \$1 a page for every page in excess of 60; brevier type to be used; 400 copies to be furnished; 10 copies to be sent by Mr. Dennis to each Councilor; and the minutes to be published in the STANDARD newspaper.

The Minutes of the afternoon meeting were read and adopted.

On motion the minutes as read from day to day were approved and passed.
