MINUTES AND PROCEEDINGS

Of the

Municipal Council of Pictou co. April Session, 1891

April 21st

Council met at 10 am. The Clerk called the Roll. The papers on file were distributed to the proper Committees.

The Warden reported verbally in the cases of Culton, Collector of County Rates for Stellarton for 1887, and of Turner, Collector of County Rates for Sec. 24 in 1888. Also in the case of John McKenzie's claim for damages due to the construction of the River John Bridge.

The Treasurer's half yearly account was read and referred to the Finance Committee.

On motion of Clr. J. D. Fraser, seconded by Clr. Dewar, it was resolved that the amount of the County's claim against the sureties of D. W. Culton be struck off the books.

On motion of Clr. J. D. Fraser, seconded by Clr. McQueen, it was resolved that the claim of the County against Turner, Collector for Sec. 24, be struck of the books.

The following resolution was moved by Clr. McQueen and seconded by Clr. J. D. Fraser.

"Whereas the County has previously met loss by defaulting Collectors of County Rates, and whereas sureties in the past have not been promptly notified of defaulting Collectors, Therefore resolved, that in future the Treasurer be requested to notify the sureties of every Collector who does not make satisfactory returns to the Council; and that such notice shall be given immediately after the January Term of Council in each year."

The resolution passed.

A communication from the Town Council of Pictou was read asking for a hearing respecting the Market Lot and New Jail.

The clerk was instructed to notify the Town Clerk that this Council will hear the Town Committees at 3 pm today.

On motion at 12:30 the Council adjourned to meet at 2pm.

AFTERNOON MEETING

Council met at 2pm. The minutes of the previous meeting were read and approved. The papers on file were distributed to the proper committees.

The Clerk read a letter from the Provincial Engineer respecting the claim of John McKenzie for damages caused by the construction of the River John Bridge. Also a letter addressed to the Warden by respecting the taxes of David McKay of Riverton.

The Bill to give the towns representation in the County councils, which has passed its second reading in the House of Assembly, was read y the Clerk in open Council.

On motion of Clr. John D. McQueen, seconded by Clr. H. S. Fraser it was resolved that the resolution of the Council providing that no private Statute Labour petitions be granted at the half yearly meeting be strictly adhered to.

Clrs. McQueen and J. D. Fraser called attention to the state of the Market in New Glasgow. The matter was referred to the Committee on Public Property.

Clr. Colin Fraser enquired whether the usual visit to the County Asylum would be made this year. Remarks were made by Clrs. McQueen, J. D. Fraser and the Warden upon the advisability of the annual visit. Moved by Clr. Alex Fraser, seconded by Clr. Campbell that the Council visit the Asylum this year as usual, and that the visit be made on Thursday afternoon. The motion passed.

The committees proceeded to work and at 5 pm the Council adjourned to meet at 10 am tomorrow.

Wednesday, April 22nd

FORENOON SESSION

Council met at 10 am. The minutes of the previous meeting were read and approved.

The papers on file were distributed to the proper Committees.

The petition of Geo. Campbell and others of Barney's River respecting the appointment of Collector for Sec. 20, was, on motion of Clrs. J. D. Fraser and R. Dewar, refused.

On motion of Clr. McQueen, seconded by Clr. W. S. Fraser, it was resolved that no papers be received by the Council after 2 pm today.

Clr. Mitchell read a petition asking for the sale of the old wharf at Merigomish, and that the proceeds be applied to the repair of the roads in the district. On motion of Clr. J. D. Fraser, seconded by Clr. Smith, the petition was received and referred to the Committee on Public Property.

Clr. J. D. Fraser called attention to the necessity of appointing a committee to see that the Pictou Steam Ferry Co. shall perform its work in a satisfactory manner. A general discussion followed. Clr. Smith moved, seconded by Clr. Ferguson that a Committee be appointed to look after the interests of the County in the matter. Clr. J. D. Fraser moved in amendment seconded by Clr. McQueen that the Committee appointed in the January Term be re-appointed. The amendment carried. The Committee proceeded to work and at one o'clock the Council adjourned to meet at 2 pm.

AFTERNOON SESSION

Council met at 2 pm. The minutes of the previous meeting were read and approved.

Clr. Murray called attention to the complaints made by residents of Trenton that their property is damaged by water overflowing from the street drains. Clrs. J. D. Fraser, A. J. McKay, J. W. Fraser, McQueen, Dewar, Ferguson, Copeland and Smith addressed the Council on the subject. The matter was referred to the Committee on claims against the County appointed in January Term.

The Committee proceeded to work and at 5 pm the council adjourned until 10 am tomorrow.

Thursday, April 23rd

FORENOON SESSION

Council met at 10 am. The minutes of the previous meeting were read and approved.

The Warden brought up the question of the claim by the Commissioners of the County Asylum against the County of Cumberland for expenses connected with a pauper. On motion of Clr. J. D. Fraser, seconded by Clr. Alex. Fraser, it was resolved that the matter be left with the Warden and Clerk to decide what action should be taken.

Clr. A. J. McKay moved the following resolution, seconded by Clr. J. D. Fraser. Resolved that the Government Grant on Roads and Bridges be expended by Road Supervisors. The motion passed.

Clr. A. J. McKay read the following Report of the Road and Bridge Committee.

Report of the Road and Bridge Committee

Your Committee beg leave to recommend that the above Report be confirmed, viz:-

The Report was received and laid on the table.

On motion Clr. J. W. Fraser was excused from further attendance for to day.

Clr. McQueen urged that no persons should be appointed road committees unless they can make the necessary surveys and plans. Clrs. A. J. McKay, J. D. Fraser, Kitchin and the Warden discussed the subject.

On motion the Report of the Road and Bridge Committee was taken up to be read clause by clause. On the clause not recommending the confirmation of the street at

Thorburn between McKay Street and the Main Road being read it was moved by Clr. W. S. Fraser and resolved that consideration of said Road be deferred to Jan. 1892.

On the clause referring to the petition for a grant of \$40 from fines moneys for a foot bridge at St. Paul's being read it was moved and resolved that the petition be granted, the money to be paid out of the first balance of fines available after costs of prosecution have been paid.

The remainder of the Report was adopted, and the recommendations therein made were ordered to be carried out.

The Warden read a telegram from the Provincial Engineer stating that the County Road Grant for the year will be \$4824.99.

Be special leave Clr. Kitchin presented the petition of Alex. Murphy asking to be relieved from the support of his mother for 6 months. On motion the petition was referred to the Committee on Poor.

Clr. J. D. Fraser read the following Report of the Committee on Railways, Report of Committee on Railways

MR. WARDEN AND GENTLEMEN:--

We, your Railway Committee beg leave to submit the following Report regarding the request of the New Glasgow Iron and Railway Co., (Limited,) for a free Right of Way for their proposed Railway.

We recommend that the Company ascertain the actual cost of the Right of Way, and submit the total amount to the Council for consideration.

We also recommend that each Councilor submit the matter of paying this Right of Way to their respective Sectional meetings previous to the next annual meeting of Council.

JOHN D. FRASER, JAMES CAMPBELL, COLIN FRASER, RODERICK MCKAY.

On motion the report was received.

On motion Mr. Harvey Graham addressed the Council upon the subject treated of in the Report.

Clr. Thompson moved the following resolution; seconded by Clr. McLeod. *To the Municipal Council of Pictou County, April Term, 1891.*

RESOLUTION

That a Right of Way be and is hereby granted to the first Company building and operating a line of railway connecting the Intercolonial Railway with the Iron Mines on the East River or at or near Sunny Brae, said the right of Way to be at a rate of \$400 (Four Hundred Dollars) per mile for each mile constructed, in the whole not to exceed \$4000, subject to the following conditions set fourth.

- I. That they shall have fully completed, equipped, and put into operation said line of Railway before July 1, 1893, which shall not be inferior in construction to the Railroad now running between New Glasgow and Thorburn.
- II. That they shall have paid or caused to be paid all wages due the workmen employed, and all charges for materials supplied for the construction of said Railway.

- III. They shall have constructed and completed and put into operation at some place in Pictou Co., a Blast Furnace for the purpose of Smelting Iron Ores.
- IV. They shall be obliged to carry all freights for all parties, coal, iron, lime, and all appliances used for the manufacture of iron at a rate not exceeding the regular rates charged by the International Railway for such freights.
- V. They shall run a passenger train at least once each way daily (Sundays excepted) on a regular schedule time table.
- VI. They shall show to the satisfaction of this Council that they have made a bona fide expenditure of at least \$400,000 (Four Hundred Thousand Dollars) in the erection and equipping of Blast Furnaces, and the construction of said Railway.
- VII. Subject to the confirmation of the Legislature of Nova Scotia.
- VIII. The Right of Way shall be paid from the proceeds of Bonds issued by this Municipality at a rate of interest not exceeding five per cent.

JAMES T. THOMPSON, ROBERT McLEOD.

On motion of Clr. Dewar, seconded by Clr. Kitchin, consideration of the Report and Resolution was deferred till to-morrow morning.

The Committee to settle the disputes between the Town of New Glasgow and the County respecting the use by the Town of the Jail and Court House at New Glasgow, reported as follows:--

We, you Committee appointed at the January Term to confer with the Town Council of New Glasgow regarding the joint occupancy of the Court House and Jail by the County and that Town, respectfully submit the following:--

We met with a Committee of that Town Council in New Glasgow on the 7th of April and discussed the matter fully in its various phases, but were unable to arrive at satisfactory conclusions. We asked from them an annual consideration of \$200 for the uses and privileges they now enjoy. To this they did not agree. We have subsequently received a letter from Mayor Sinclair containing an offer of \$150. We think this Council should insist on the amount of \$200. We therefore submit this matter to the careful consideration of the Council for their approval or rejection.

We your Committee appointed to meet the Town Council of the Town of Pictou regarding their request for accommodation in the County Jail for their prisoners, beg leave to report.

We met by appointment with their Committee on the 21st inst., and heard their request. They ask for the use of two cells, for which they would agree to pay the sum of \$50 per annum of \$1 for each prisoner they put there, they paying their board and furnishing these cells. We therefore submit this matter to the careful consideration of the

full Council for their approval or rejection. We suggest that if this request be granted it be not binding for more than one year.

And also that the said Boundaries defined be Boundaries of Poor District No. 23. And that this be the Boundaries of Polling Section No. 12, where it bounds on Section No. 23.
