# MINUTES AND PROCEEDINGS Of the

# Municipal Council of Pictou co. JANUARY SESSION, 1891

#### **First Day**

Forenoon Session, January 13, 1891- The Councilors elect met at 10.a.m. The ballot boxes were opened and the Councilors elect were sworn into office by the Clerk. All the councilors were present.

On motion of James Kitchen, seconded by Jas, T. Thompson, Roderick McDougall, Councilor for Section 22, was unanimously elected Warden. The Warden was sworn into office.

On motion of Clr. J.D. Fraser seconded by Clr. Kitchen, Alex J. MacKay was unanimously elected Deputy Warden.

The following Committee on Nominations was appointed by Warden and approved by the Council: - H.S. Fraser, A.J. MacKay, George M. MacKay.

On motion it was resolved that no petitions would be received after Monday next at 2:30 p.m.

On motion of Clr. J. D. Fraser the Nominating Committee was entrusted to name a committee to prepare a resolution to expressing the sentiments of the Council respecting the late Warden Robert MacNeil.

Clr. Dewar gave notice of his intention to move on Thursday forenoon the appointment of a Committee to consider and recommend certain amendments to the Incorporation Act. On motion the Council adjourned until 2 p.m.

Afternoon session. – The council met at 2 p.m. The minutes of the previous meeting were read and approved.

On motion the Report was received and adopted. The papers on file with the Clerk were distributed to the proper committees.

On the report of the committee appointed in April 1890 to appraise the damages upon the abandoned part of the short lines railway being read, on motion of Clr. J. D. Fraser the Report was received and laid on the table.

On motion the Council adjourned until 10 a.m. tomorrow.

#### **Second Day**

Forenoon Session, Wednesday January 14<sup>th</sup> 1891- The council met at 10 a.m. The minutes of the previous hearing were read and approved.

The papers filed by the clerk since last meeting distributed to the proper Commitees. Clr. Dewar asked for the information adopted by the Board of Revision and Appeal in equalizing the valuations of the different Polling Sections. His request was by Clr. Mitchell. Clr. Thompson explained at length the method of the Board in 1889 and 1890. The discussion was participated in by Clrs. J.D. Fraser, J.D.McQueen, J.W. Fraser and Colin Fraser.

On motion of Clr. J.D. Fraser the nominating committee was instructed to name a Committee on Law Amendments.

The Report of Wm. Smith, Inspector under the Scott Act for East Pictou was read by Clr. J.D. McQueen. On motion of J.D. the report with the accompany account on vouchers was received.

Clrs. J.W. Fraser and John Ferguson drew attention to the matter of holes cut in the ice near the bushed tracks, and to the danger arising from the open water caused by the Str. "Stanley." Clrs. J.D. Fraser, R. Dewar, James Mitchell and John D. McQueen joined the discussion. On motion of the matter was referred to the Committee of Law Amendments. On motion of the Council adjourned at one o'clock to meet at 2 p.m.

Afternoon Session. – The council met at 2 p.m. The minutes of the previous meeting were read and approved.

The Nominating Committee reported as follows:-

Clr. Geo. E. Munro read a memorial from the Executive Committee of the Probation Party asking for the appointments of a Scott Act Inspector in Westville. Also resolutions of several Temperance bodies with the same object. On motion of Clr. Dewar the Memorial and Resolutions were received and on motion of Clr. Kitchen they were referred to the Nominating Committee.

Clr. Geo E. Munro presented a petition to asses Westville District for five purposes. On motion the petition was received and referred to the Finance Committee.

Clr. Alex Fraser gave notice to his intention to movie to petition the Government for a grant of money for the repair of certain

The Committees proceeded to work and at 5 p.m. the Council adjourned til 10 a.m. tomorrow.

### **Third Day**

Forenoon session, Thursday Jan. 15. The council met at 10 a.m. The minutes of the previous meeting were read and approved.

The papers on file with the Clerk were distributed to the proper committees.

On motion a petition to annex Big Island, Merigomish, to Sec. 21, was read in open Council and referred to the Committee on Law Amendments.

Clr. Thompson read a petition asking for a grant from the fines money towards the construction of a bridge a mile above St. Paul's Sec. 16. The petition was referred to the Finance Committee.

Clr. Colin Fraser drew attention of the Council to the growing abuse connected with the allowance of Statute Labor on private roads. Clr. A.J. MacKay said the present system was just and worked well, though in some cases perhaps it was abused. Clrs. Dewar Thompson, Geo. McKay, John Murray, John D. Fraser and James W. Fraser joined the discussion.

Clr. Dewar read a series of resolutions in favor of certain amendments to the Municipal Incorporations Act. On motion it was received and referred to the Committee on Law Amendments.

The Nominating Committee reported as follows:-

Nominating Committee

On motion of the Report was received and adopted.

Cir. W. Scott Fraser called attention to the use made by the incorporated Towns of the County property within the towns. Clr. Kitchen spoke of the matter of lockups in towns and pointed out that the county ought not to be liable for any part of the expense of these.

Cir. J.D McQueen showed that the Scott Act fines collected in the towns go to the Town funds while persons convicted are imprisoned at the expense of the County.

Chris J.W Fraser, Alex Fraser, J.T. Thompson and J.D. Fraser joined in the debate and the matter was on motion deferred.

Clr. Ferguson drew attention to the state of the approaches to the ice at Ferry Wharf, Fisher's Grant. A discussion followed and the matter was deferred.

The Committees proceeded to work and at 5 p.m. the Council adjourned to meet at 10 a.m. to-morrow

#### **Fourth Day**

Friday January 16<sup>th</sup>, 1891 – The Council met at 10 a.m. The Minutes of the previous meeting were read and approved.

The papers on the file with the Clerk were distributed to the proper Committees.

Clr. J. Ferguson moved the following resolution, seconded by Clr Mitchell.

Whereas the Public Landing at Fisher's Grant was destroyed by high tide in December last and is no in a dangerous condition, and whereas said Landing is not included in any Road Limit;

Therefore resolved that the matter be referred to No. 1 Road Board.

The Resolution was passed.

Clr. Alex Fraser presented the following petition:-

Court House, Jan. 16, 1891.

To the Municipal Council, Jan. Term, Now Convened.

I beg leave to ask your Hon. body as Finance Committee to raise your estimates for the bushing ice enough to cover the expense of putting in another row of bushes in the East End of Carriboo Harbor, as it is requisite and necessary, as a great many land now at the shore on main land, as it is shorter and a better road to market.

The petition was received and referred to the Committee on Finance.

Clr. J. D. McQueen called attention to the action of Geo. J Geldert against the Municipality for damages for injuries received at River John Bridge, which action was tried at last June Term of the Supreme Court, and resulted in a verdict for the plaintiff for \$7250 and costs. He read the decision of the judge. A general discussion followed, and the whole matter of the County liability in such cases was referred to the Committee of Law and Amendments. Clr. Colin Fraser suggested that legislation would be more likely to procure through co-operation with other Municipal Councils.

The Committees proceeded to work and at one o'clock at the Council adjourned to meet at 2 p.m.

Afternoon Session – Council met at 2 p.m. The minutes of the previous meeting were read and approved. Clr. Dewar explained that his absence yesterday afternoon was due to the visits made by him to the County Asylum and the New Glasgow Court House in his capacity as Chairman of the Committee on Public Property; and that Clr. W. S. Fraser was also delayed by County business. On motion it was resolved that their time so spent be allowed to them.

Clr. Colin Fraser moved the following Resolution, seconded by Clr. Hugh S. Fraser:"Whereas a new bridge has been built under the Bridge Act across the Saw Mill Brook in
Polling Section Number 7 and the old iron bridge on said brook is not now used.
And Whereas the said old bridge is in danger of being broken up and destroyed and the
materials of it may be utilized for the construction of a new bridge at Millers Ford or Ten
Mile House West River.

Therefore Resolved that the Provincial Government be respectfully requested to remove said iron bridge from its present position and place it across West River at either of the places above mentioned.

The resolution was passed and ordered to be sent to the members for the County in the Local Legislature to be presented to the Government.

Cir. J.D. McQueen stated that when the Town of Stellarton was incorporated parts of the Polling Station No. 25 were left outside the boundaries of the Town and great inconvenience had resulted. A general discussion followed. Clr. Said the bridge across the East River of Stellarton which was formerly within Sec. 25 is not within the boundaries of Stellarton. On motion of Clrs. J. D Fraser and Colin Fraser the matter was referred to a special Committee to consist of the Councillors interested and to be named by the Nominating Committee. Said Special Committee to report at this Session and make a recommendation to the Legislature.

The Committees proceeded to work and at 5:15 p.m. the Council adjourned till 10 a.m. to-morrow.

Fifth Day

Forenoon Session, Jan 17, 1891. – The Council met at 10 a.m. The minutes of the previous meeting were read and approved.

A petition to rectify the boundaries between polling sections 19 and 20 so as to include Marshy Hope Mountain in Sec. 20, was read in open Council and ordered to be sent to the Members for the County for presentation to the Legislature.

Clr. James W. Fraser complained that they services rendered by the Pictou Steam Ferry Company were not accordance with the understanding expressed when the subsidy was granted inasmuch as their ferry boat does not run to Granton or Abercrombie. The subject

was discussed by several Coucillors and the matter was referred to the Nominating Committee to name a Committee on the subject to report at the April Term.

Clr. Alex Fraser moved the follow resolution, seconded by Cir. R. McKay. Court House Jan. 17, 1891.

Whereas the bridge at Lower Carriboo River has been put under the provisions of the Bridge Act, and whereas the said bridge is unsafe and dangerous to the traveling public. The Resolution was received and ordered to be transmitted to the Members for the County for presentation to the Legislature.

Clr. J.D. McQueen moved, seconded by Clr. J.D. Fraser as follows:

"Resolved that the order passed last year regarding the bushing of the ice be so amended that the distance of 90 feet apart be substituted instead of 45 as it now exists."

On motion the Resolution was passed.

Clr. Thompson gave notice of his intention to move for a subsidy to the first. Company that shall manufacture iron on the East River. It was agreed that the motion may be introduced on Monday afternoon.

The Committees proceeded to work and at one o'clock the court adjourned to meet at 2:30 p.m. on Monday.

#### Sixth Day

Monday Jan. 19<sup>th</sup>, 1891 – Council met at 2:30 p.m. pursuant to adjournment. The minutes of the previous meeting were read and adopted.

Clr. J.W. Fraser stated that it was important to have the ice bushed from Stone House Point to New Glasgow. After some discussion the matter was referred to the Finance Committee.

Clerk H.S. Fraser read the following report for the Nominating Committee:- We your Nominating Committee beg leave to recommend that J.W. Fraser, Jno. Murray, George E. Munro, Robert McLeod, W. Scott Fraser, be a committee to investigate the matter in relation to parts of Poll Sec. 25, previous to the incorporation Stellarton, which are not now included in said Incorporated Town, nor any of the surrounding sections and make a recommendation to the Legislature respecting the same.

The following petition from the Pictou Agricultural Society was read in open Council; To the Municipal Council Pictou Co., N.S.

Gentlemen: - The Petition of the officers of the "Pictou Agricultural Society" Whereas your honorable body did in the year 1881 contribute of the County funds towards the purchase of a lot of land from W.N. Mills adjoining the Rink building in Pictou Town, for exhibition purposes and the Deed of said lot of land is held by the County.

And whereas the property has been found unsuitable for exhibition purposes and your petitioners have within the past year 1890 purchased more suitable property and erected

permanent Buildings and sheds thereon at a cost to your petitioners of over \$3000 and whereas it is the intention of your petitioners to apply at the first session of the local Legislature for an act of Incorporation.

Therefore the prayer of your petitioner is, that your honorable Council will convey the said "Mills property to us by Deed thus enabling us to dispose of same and to apply proceeds of same to our new grounds, the said Deed to be granted to our becoming incorporated.

On motion of Clr J.W. Fraser, seconded by Clr. D. Fraser, the petition was granted. The following petition from the Stewiacke Valley and Lansdowne Railway Company

Limited Respectfully sheweth.

That a subsidy of eight thousand dollars was granted by the Municipal Council of Pictou County is January, 1888, in aid of the said Company's Railway in Pictou County upon condition of the Railway being open for traffic on 1<sup>st</sup> July, 1891.

That unforeseen difficulties and delay have occurred which render it impossible to have the Railway completed by the time specified.

The recent financials disturbances in the money market render it difficult to have the Railway open for traffic as soon as the Company desires.

Your Petitioner therefore applies to your honorable council for a renewal of the subsidy of eight thousand dollars in aid of said Railway payable within four years.

And your petitioner as in duty bound will ever pray.

The petition was received and referred to the Railway Committee.

Clr. Thompson read the following motion seconded by Robt. McLeod.

"I Whereas at the January session 1888 of the Municipal Council of Pictou County, a resolution was passed granting \$2000 a mile as a subsidy in aid of a railway connecting Iron Mines with the I.C. Railway not exceeding the whole \$20000.

And whereas there are now several Companies operating and about to operate Iron Mines in Pictou County.

Therefore Resolved, subject to the conditions hereinafter set fourth and to confirmation by an Act of Legislature of Nova Scotia, that a subsidy be granted by the Municipal Council of Pictou County to the first Company that complies with the conditions hereinafter set forth in aid of a railroad connecting the Iron Mines at or near Sunny Brae, with the I.C.R.

II That the subsidy shall be \$2000 per mile of said Company's railway but not exceeding in the whole the sum of \$20000 exclusive of any subsidy that may be granted by any of the incorporated Towns of Pictou County.

3. Upon the opening of Company's said Railway for the traffic the said subsidy shall be paid for the first Company complying with under motioned conditions, from proceed of Bonds which shall be issued by the Municipality of Pictou County falling due within 15

years from time of issue with interest at rate not exceeding 4 (per. cent) payable yearly on the first day of December.

- 4. No Subsidy shall be paid nor Bonds issued by the Municipality on account of the Company's said Railway unless the following conditions be complied with, that is to say: (A.) That the Railway shall be the same gauge as the Intercolonial R. R., substantially built and of a standard not inferior to the Railway between New Glasgow and Thorburn. B. That the Railway shall be opened for traffic and an expenditure made of not less than \$250,000 on a new Iron. Smelting works, exclusive of any money spent in the construction of said Railway, and that sixty thousand tons of pig iron be smelted by said furnace to be situated in Pictou County.
- C. That said pig iron shall be manufactured from Iron Ore mined and procured in said County of Pictou with proof thereof furnished to the Municipal Council of said County before the last day of January term Council 1896.
- D. It is further understood that before bonds shall be issued by said Municipality for said subsidy the Company claiming such subsidy shall show to this Council of Pictou County that they are in a solvent condition also that the industry benefited by said subsidy shall be shown beyond a reasonable doubt to be a permanent one.
- 5. Notwithstanding anything herein before contained the subsidy herein provided for shall not be paid until the Company claiming it shall satisfy the Municipality of Pictou Co. that so much of their property as is aided and abetted by this subsidy shall not then or subsequently by amalgamation or otherwise come under the provisions of a resolution passed in the Council that the 20<sup>th</sup> day of Jan. 1886, and ratified by Chapter 190 of the Statutes of Nova Scotia 1886, so far as exemption from taxation is concerned. It was moved by Clr. J. D. Fraser, seconded by Clr. Kitchen that the Motion be received and laid on the table. Moved in amendment by Clr. J.W. Fraser, seconded by Clr. G.M. McKay that the motion be received and referred to a special Committee. The Amendment was defeated by 5 to 15, and the motion carried the same vote.

Clr. Dewar moved the following resolution seconded by Clr. Alex Fraser: - Whereas there appears to be an impression on the minds of the Rate Payers that there has been an annual increase of each annual estimate from the year 1870 of the year 1890; also a correct statement of the total liabilities of the Municipality of Pictou up to date, all to be

placed before the Council at the April meeting.

Clr. A.J. McKay brought up the question of the Public Market in the Town of Pictou, and read the draft of a proposed Bill to be introduced at the net Session of the Legislature to enable the Municipality to dispose of the Market property. The document was referred to the Committee on Public Property.

Clr. Kitchen said complaints had been made by some of the Judges as to the lack of furniture in the Judges Room. The Sheriff, on invitation addressed the Council on the matter, which was thereupon, at the suggest on of the Warden, referred to the Committee on Public Property.

The Committee proceeded to work, and remained in session until 5.p.m. when the Council reassembled. Clr. J..W Fraser moved, seconded by Clr. John Murray, as follows – Whereas there is a vacancy in the Board of Revisors of the Electorial Lists for Revisal

Section Number 8, Polling Sections 12 and 17, for the unexpired portion of the Revisal year, 1890-91.

The resolution passed and the appointment was made.

Clr. Roderick McKay moved seconded by Clr. George. M. McKay as follows;-

Whereas a vacancy had occurred in the Board of Revisors of the Election Lists for Revisal Section No. 3, Polling Sections Nos. 5 and 6 owing to the Election of Roderick McKay one of their number as a member of this Council.

Therefore resolved that Alexander Gratten of Millville, Shoemaker, be and he is hereby appointed a revisor for Revisal Section No. 3 in the room of said Roderick McKay.

The resolution passed and the appointment was made.

On the motion the Council adjourned until 10. a.m. tomorrow.

#### Seventh Day.

Forenoon Session, Tuesday January 20<sup>th</sup>, 1891 – The Council met at 10 a.m. The minutes of the previous meeting were read and adopted.

The petition from the New Glasgow Iron Coal and Railway Co. asking for a subsidy was read. Clr. Thompson moved seconded by Clr. J.W. Fraser that the petition be received and referred to the Railway Committee.

Clr. McQueen moved in amendment, seconded by Clr. J.D. Fraser that the petition be received and that it and resolution be read by Clr. Thompson yesterday and then laid on the table be referred to the Railway Committee with instructions to report at the Half-yearly meeting. The amendment was carried by a vote 19 to 5.

A petition for aid to the road from Trenton to Little Harbor a petition to widen the road from Concord to Glengarry, a petition for a public road from New Lang to Lansdowne and a petition respecting Statute Labour from Sec. 7. were on motion in each case, received and referred to the proper Committees.

Clr. McQueen read the following report:

Resolution Respecting the Late Warden.

Therefore Resolved, that the Council at the first meeting since the occurrence of this sad event, desire to place on record their deep regret for the loss the County has met by his death; as we frankly admit that he possessed a power and breadth of thought attested to by the results which he achieved. And we agree to record on the Minutes of our Council our high appreciation of his integrity, prudence, and faithfulness whilst discharging the duties of pertaining to the office of Warden of the Municipality.

Report of Committee on Public Property

Your Committee beg leave to report as follows:

- 1. Your Committee find the County Asylum Building in good order. Some slight repairs required. A fire escape is now under contract and will become a source of income to the County. Your Committee are of the opinion that the farm in connection with the Asylum is being well managed and will become a source of income to the County. Your Committee recommend that the Commissioners enquire as to the cost of Telephone connection with the town of Stellarton.
- 2. Your Committee find the interior of the Court Room in New Glasgow in need of some repairs, but your Committee recommend that a Committee of this Council be appointed to meet with the Town Council of New Glasgow and make an agreement or settlement of contentions now existing on account of the joint occupation of the Court Room and jail.

Your Committee find that no repairs have been made on the Market Building and as it has now become an eye sore and a public nuisance, your Committee recommended that the Clerk call for tenders for the purchase and removal of the building from the market lot, as the building is of no further use to the Town or County. Your Committee do not think there is any reason why it should be removed without the necessary delay arising out of legislation.

Your Committee recommends under the circumstances that the Ferry Company receive the subsidy granted by this Council for the past year. We recommend that in future a list be prepared of the names of all Surveyors of highways whose returns are not duly made on or before the first day of the yearly meeting of this Council, with a view to the exaction from such surveyors of the penalties imposed by law.

We also recommend that the following resolution be passed and printed in or annexed to the instructions sent to the Surveyors.

"Every Surveyors of Highways shall endorse upon his return the dates of commencement and completion of Statute Labor in his road limit."

It is well known that in many cases Statute Labor is not performed until the fall of the year, when it is generally useless, and as the amount of Statute Labor available in this County is insufficient to keep the roads in a proper state of repair, your Committee is of opinion that legal means should be resorted to in order to secure that the Statute we gave should be employed to the best advantage, and we are convinced that such labor would go a great deal further than it does if it were performed in all cases during the proper season.

Your Committee had under consideration a petition from certain ratepayers resident in Hopewell, Section 17, asking to abolish Statute Labor in limit 429, and divide the labor between limit 428 and 430. A counter petition was also received from certain other rate payers of Hopewell asking that the prayer of the first mentioned petition be not granted.

Your Committee would recommend that the present limits be retained during the present year.

- 1<sup>st</sup>. That Dr. McMillan be paid the sum of \$25.00 for Jails services for 1891 per agreement.
- 2<sup>nd</sup>. That the Commission to be paid Collectors of County rates for 1891 be 3 per cent in all Sections of the County.
- 3<sup>rd</sup>. That the sum of four hundred and eighty-five dollars (\$485) be assessed for Police purposes, and sixty five dollars (\$65) for fire purposes on Westville Police Division for the current year.
- 4<sup>th</sup>. That \$20 be granted for a Ferry between Carriboo Island and Main land subject to existing regulations.
- 5<sup>th</sup>. That the payments by the Treasurer in Treasurer's account for 1890 as contingencies be approved of.
- 6<sup>th</sup>. That no Jail Fees be paid by the County.
- 7<sup>th</sup>. We recommend that no commissions be paid to the County Officials for collecting or disbursement of monies which come under their hands in the discharge of their duties, unless authorized by the Council.
- 8<sup>th</sup>. We have examined the accounts of William Smith, Inspector under the Scott Act. We fins that he paid \$100 previous to December 31<sup>st</sup>, 1890; and that there was a balance of \$122.18 in his hands Dec. 31<sup>st</sup>, 1890, out of which \$100 has been paid unto the County Treasury, he retaining \$28.18 till cases still pending be settled.

We have also examined the account of James Murdock and find a balance of \$20.27 still unpaid and due County. And the accounts of A.R. Watt, the former Inspector for Pictou, showing a balance due him of \$250.62 for legal expenses in re appeal case Henry Gammon taxed against Gammon but which the Inspector has been unable to collect. We would recommend that in future all Inspectors consult the Warden before incurring any expense in the Supreme Court.

- 9<sup>th</sup>. We recommend that the sum of \$175.00 be paid the Pictou Ferry Co. as per resolution of Council, January Term, 1888, for subsidy.
- 10<sup>th</sup>. We recommend that the report of the appraisers appointed to appraise the damages on the abandoned portions of the Short Line Railway be approved and the sum

of seven hundred and sixty-six dollars (\$766.00) be placed in the estimate of the present year to meet the amount of said appraisement.

- 11<sup>th</sup> We beg leave to call the attention of Coroners to the law providing that no fees be paid to medical witnesses at Inquests unless the evidence of such witnesses be called for by majority of Jurors, and that the vouchers therefore be signed by the Coroner and Chairman of the Jury.
- We also recommend that in future all accounts against the County be certified by the party ordering the work and material for which the account if charged.
- 13<sup>th</sup>. We recommend that one line of bushes on Pictou Harbour extend on the East River as far as the Northern limit of New Glasgow, and that an additional row be placed on the each end of Carriboo Harbour.
- 14<sup>th</sup>. We recommend that the salary and expenses voted for Warden for 1890 be paid as follows: that the executors of the late Warden be paid the sum of \$50 and the balance \$75 be paid the present Warden for expenses, etc. as Deputy Warden.
- 15<sup>th</sup>. We recommend that the Committee appointed at the April meeting, 1890, for the purpose of building a new Jail for the County be paid the sum of \$50, as remuneration for their traveling expenses.
- That the Treasurer make immediate demand for the amounts due from the Towns for County Assessment, and that interest be charged on the amount due for taxes from the 1<sup>st</sup>. of July in the year in which they became due at the rate of six percent per annum. # Report of the Railway Committee Court House, Pictou, Jan. 22, 1891

The Special Railway Committee met at 2 p.m. and appointed John D. Fraser Chairman, and John D. McQueen, Secretary.

The Petition of the Stewiacke and Lansdown Railway Company was read and considered, and it was agreed to recommend that the prayer of the petition be granted subject to existing legislation.

On motion the Report was received.

Clr. J.D. Fraser explained the reasons of his addendum to the petition. Clr. McQueen stated the reasons that actuated the majority of the Committee, one of which was that in their own opinion to refuse an extension of time would be a practical breach of faith on the part of the County. Clrs. Dewar, Colin Fraser, Roderick McKay, J.W Smith, A.J. McKay, spoke upon the subject, and on motion the Report was adopted.

Clr. G.M. McKay read the following Resolution.

Whereas by a Resolution of the Municipal Council of Pictou County passed on the 19<sup>th</sup> day of January A.D. 1888, it was in effect provided that a subsidy not exceeding eight thousand dollars be paid to the Stewiacke Valley and Lansdowne Railway Company Limited in lieu of a right of way in Pictou County on condition of the Company's Railway being open for traffic in said County on or before the 1<sup>st</sup> day of July 1891.

And whereas application has been made for an extension of time and renewal of subsidy in consequence of unforeseen difficulties having arisen delaying the completion of the Railway. Be it therefore resolved:

- 1. A subsidy of eight thousand dollars, in lieu of free right of way, is hereby granted to the Skewbacks Valley and Lansdowne Railway Company Limited in aid of the line of Railway proposed to be built by the said Company in the County of Pictou from Colchester County line through Lansdowne.
- 2. That said subsidy shall be paid to said Company from the proceeds of bonds which shall be issued by the Municipality of Pictou County falling due in twenty years from the time of issue with the interest payable yearly at the rate of five per cent annum upon completion of said railway from Colchester line to Lansdowne in Pictou County ready for rolling stock, provided proof thereof be furnished to said municipal Council on or before the 1<sup>st</sup> day of February A.D. 1895.

Moved by William McLeod. Seconded by A.J. McIntosh The Resolution passed. On motion at 5.15 the Council adjourned until 9.15 a.m. tomorrow.

#### Tenth Day.

Forenoon, January 23<sup>rd</sup>, 1891.- The Council met at 10 a.m. The minutes of the previous meeting were read and approved.

The Nominating Committee beg leave to recommend that the following Committee be appointed as a Jail Committee to look after the interests of the County in connection with said jail, viz:-James Kitchen, Robert Dewar, James Campbell, Alex. Fraser, John Ferguson.

On motion the Report was received and adopted.

Clr. Kitchen read the following report of the Committee on the proportion of County rates to be paid by the Towns:-

# Report of Committee to Apportion Rates with Towns of Pictou, New Glasgow, and Steallarton.

To the Municipal Council of the County of Pictou, January Term, 1891.

Your committee appointed to meet with the Committees of the Town Councils of Pictou, New Glasgow, and Stellarton to apportion the County rates to be paid by these Incorporated Towns to the Municipality beg leave to report as follows:-

Your committee did not succeed in coming to an agreement with the town of Pictou. The Town Council claimed a reduction of one per cent on the amounts free upon in previous years which your Committee could see no adequate reason for, as the valuation of the Town has not decreased. Upon the basis of the previous years, the amount to be paid by Pictou Town should be 3,066.90. less than 101.00 an over charge in the last years agreement, leaving a balance of \$2965.90 to be paid the Town. Your Committee recommend that no smaller amounts be agreed on, and that an arbitrator be appointed by this Council in order that the provisions of the law in such cases may be carried out.

On motion of Clr. A.J. McKay the nominating Committee was instructed to name an "Arbitrator Committee" under Chapter 27, Acts of 1886, and an Arbitrator under Sec. 101 of the Municipal Incorporation Act.

On motion the Sureties on the Treasurer's Bond for 1891 were accepted and the Bond approved.

The report of the Committee on Law and Amendments was taken up to be read clause by clause. On the clause of 1888 Report, referring to auditors being read, Clr. Colin Fraser moved, seconded by Clr. McQueen, that the clause be struck out. The motion was defeated. On the clause referring to the election of Councillors being read, it was moved by Clr. A.J. McKay, seconded by Clr. W.S. Fraser that the clause be struck out. The motion was defeated. All the remaining clauses were adopted, and on motion the report as a whole, as amended, was adopted. The following is the Report as amended.

#### Report of Committee on Law Amendments

To the Municipal Council of the County of Pictou, Jan. 1891:

Your Committee on Law Amendments beg leave to report as follows:

1. That the amendments specified in Section (a), Subsections 1 and 2 of the Report of the Law Amendment Committee in January 1888 be embodied in a bill and submitted to the local Legislature at the ensuing session.

We also recommend as follows-

That the Surveyors of Highways appointed by the Council to discharge the duties by Chap. 47 fifth series upon written notice by a ratepayer that a bridge is broken, or the highway is dangerous or impassable shall apply to a Councillor of the road board who shall grant the said surveyor an order to forthwith proceed to cause the necessary repairs, which shall be his sufficient authority to order all persons liable to perform Statute Labour to work with the necessary implements and teams in order that the same may be passable and safe; and every person liable not complying with the order shall for every omission forfeit one dollar for each day that he is liable to labour by such order, but no person shall be obliged to furnish more days labour than he was liable to perform in the term previous to such order.

Surveyors of highways refusing to comply with such order of Councillor shall be liable for one-half the damage caused by delay. Such liability not to exceed forty dollars.

When the Surveyor of highways shall be unable to complete the necessary repairs with the labour at his command he shall notify a Councillor of the Road Board who shall order the Supervisor of the road in which the repairs are needed, to complete said necessary repairs.

We also recommend that Sections (b), (c), (d) and (e) of the Report of the Committee on Law Amendments in January Session 1888, be embodied in a bill and submitted to the Legislature at the ensuing Session thereof.

That Sec. 11 of said Chap. 56 should be amended by adding the following words; "Every candidate shall pay or cause to be paid to the presiding officer in the Polling district for which said candidate is nominated at least ten clear days before the time of

holding said election the sum of twenty dollars, which the presiding officer shall acknowledge.

The sum so deposited by any candidate shall be returned to him in the event of his being elected or by his obtaining a number of votes at least equal to one half of the number of votes received by the candidate elected in the Polling Section where the election is held.

That Sec.51 of said chapter be amended by changing the word *three* to the word *one* in said section.

That Sec. 8, Chap. 56 be amended as follows:

The Municipal Council may appoint more than one presiding officer in each Polling District and may fix the place where the Poll shall be taken by each presiding officer in cases where more than one presiding officer shall be appoint in any Polling Section. The Council shall have power to make all necessary regulations for the counting of ballots and declaring the results of the poll.

We recommend that eh Clerk be appointed a special Committee to prepare a bill of the foregoing recommendations and forward them to the Provincial Assembly for their approval.

Clr. Kitchen read the Auditors Report as follows:-

#### **Auditors Report**

To the Finance Committee of the Municipal Council January Term 1891.

Your Auditors beg leave to report that they have examined the accounts submitted to them and marked the inaccuracies therein.

They have also examined the books of the Treasurer and the books and papers of the Secretary of the Commissioners of the County Asylum and found them correct and kept with much care and neatness.

They would recommend that all accounts rendered without the necessary vouchers or certificates be either returned or laid over until they are properly certified, and hope that this recommendation will be strictly carried out.

Clr. Kitchen read the following Report of the Committee appointed in April 1890 to provide for the construction of a new jail:-

#### Report on the New County Jail

To the Municipal Council of Pictou County

The Committee appointed at the half yearly meeting in 1890, to provide for the erection of a new jail on the lot in rear of the Court House Pictou, beg leave to report as follows:

- 1. The Committee met soon after the Council adjourned and after making careful inquiries came to the conclusion that the difference between the cost of a jail wholly built of stone and brick, and that of a jail partly constructed of wood, would be more than made up by the greater durability and lessened expenditure on repairs, of a stone and brick building.
- 2. Notices were accordingly published about eh first of June inviting architects to send in plans and specifications for the erection of a stone jail with brick cells, on the lot above mentioned, and offering the sum of \$50 for the plan and specifications which might be accepted. Several architects responded to the invitations, and after careful deliberation, the Committee selected the plan and specifications submitted by Melville McKean, Architect Pictou.
- 3. Tenders for the erection of a jail in accordance with said plan and specifications were asked for by public advertisement, and following tenders were received:—McKean and Murray, Pictou, \$11,800; McDonald and Ferguson, Pictou, 12,700, Dan McDonald, Pictou, \$12, 250, J.K. McDonald, New Glasgow, \$17, 250l John McIntosh, Stellarton, \$11, 982, and D.W. Murray Pictou, \$11, 775.
- 4. None of the said tenders was accepted, but your Committee made certain modifications in said plan and specifications, with a view to reducing the cost, without impairing the security or durability of the jail, and sent a copy of such tenders asking him to state what reduction he would make in his tender, on account of said medications.
- 5. All the tenderers replied, and on examination it was found that the tender of Mssrs McKean and Murray, as so amended, was the lowest being for the sum of \$10, 660 and they having furnished adequate security the contract was filed with the Clerk and is now submitted for inspection.
- 6. The Contractors commenced work about the first of August and covenanted to finish the building by the 31<sup>st</sup> December 1890.
- 7. The work is not yet completed, but the Committee is of opinion that so far as they have gone, the Contractors have done the work well, and that the building is being erected in a workmanlike manner.
- 8. The Committee appointed Daniel McDonald, of Pictou, to be inspector, at a salary of \$2.50 per day. He has given his whole time to the work, and the Committee is satisfied that he has carefully guarded the interests of the County.
- 9. Payments amounting to \$6000 have been made to the Contractors, leaving a balance of \$4660 to be paid within a month after the completion of the contract.
- 10. The Committee thought it advisable that the Court House and Jail should be heated from one boiler to be placed in the jail and accordingly required the Contractors to excavate a boiler pit in the jail cellar sufficiently deep for the purpose mentioned, and to leave an aperture in the foundation wall through which

- the hot water pipe to the Court House may be laid, if the Council deems it advisable to carry out the intention of the Committee. We are of opinion that if this project be carried out it will result in a saving of at least \$100 a year.
- 11. It became necessary to construct a sewer from the new jail to low water mark on the shore of the harbour, and the Committee entered into negotiations with the Town Council of Pictou, to ascertain whether some arrangement could be come to make this sewer a part of the proposed sewerage system of the town. After securing estimates and tenders it was found that a sewer of the dimensions necessary to suit the Town system would cost \$1200, while a sewer sufficient for the jail could be constructed for \$300. The best offer made by the Town Council was to pay one-half of the cost of the larger sewer, and accordingly your Committee awarded to the lowest tenderer a contract for the construction of a sewer sufficient for the jail. D.W. Murray, of Pictou, was the lowest tenderer, his contract price being \$300. The sewer has been dug and the pipes laid, but the whole work of filling in has not yet been completed. The sum of \$150 has been paid to Mr. Murray on account.
- 12. Before this sewer could be laid permission has to be obtained from the Town Council to run the same under certain streets, and from Mr. Russell Johnstone to pass across and under his lands between Water Street and the harbour. The Town Council gave permission to use the streets free of charge, and a deed was obtained from Mr. Johnstone giving the necessary easement for \$50.
- 13. It appeared to the Committee desirable to run the Court House cellar drain into the new sewer, and the Contractor was instructed to leave a T so that this connection can be made if the Council so orders.

The Committee begs leave to make the following recommendations:

- 1. That a Committee be appointed with power to have the new jail properly furnished, to have the necessary heating apparatus placed in the Court House cellar drain with the new sewer, and also to adjust all accounts with the Contractors, and report at the half-yearly meeting.
- 2. That application be made to the Local Legislature at the ensuing session thereof for power to issue debentures to cover the cost of erecting the new jail, including all expenses of architect, inspector, the construction of the sewer and heating apparatus, and the necessary furniture, and all other expenses connected therewith.

And also that said Poor District No. 8 be assessed for said amount.

Clr. A.J. McKay read the following Report of the Nominating Committee.

We your Nominating Committee do hereby appoint Geo. Gordon, of River John, as Arbitrator to adjust rates between the Municipality of Pictou County and Pictou Town.

We recommend that the following Councillors be Arbitration Committee under the provisions of Chapter 27 of the Nova Scotia Acts of 1886, viz: John D. Fraser, John D. McQueen, Rod McKay.

The Report of the Commissioners of the County Asylum was on motion read by Clr. Kitchen.

The following is the Report.

# Report of the Commissioners of the Pictou County Asylum for the Year Ending Dec.31<sup>st</sup>, 1890.

To the Municipal Council of Pictou, January Term 1891.

The Commissioners of the Pictou County Asylum beg to submit the following report for the year ending Dec.31<sup>st</sup>, 1890.

By last years report the balance against the Asylum was \$10859.13. The total expenditure this year, including interest and Commissioners salary, amounted to \$8713.12 which together with last year's balance amounted to \$19572.25.

The receipts for the past year were as follows:

Received from Poor Sections \$1387.03

- " for Support of Insane 89.53
- " From farm produced sold 111.93
- " N.S. Government for insane patients 203.50
- "County Treasurer 5500.00

Total \$7291.99

Which is being deducted from \$19572.25 makes liability of the Commissioners to be \$12280.26. Of this amount \$5280.26 is due the Merchants Bank of Halifax, and \$7000.00 by notes of hand to private parties, the former bearing interest at the rate of 6 per cent, and the latter at 5 per cent per annum.

The Commissioners beg to call the attention of the Council to the fact that while they asked for \$6500 for the support of the Asylum for the past year, they received only \$5500 from the County Treasurer. This failure on the part of the County, to furnish with sufficient funds for the maintenance of the Asylum, together with an unforeseen increase of expenditure, has caused a deficit during the year of \$1421.13. We would further call the attention of the Council the fact that the whole liability of the of the County, on behalf of the Asylum amounting to \$12280.26 is now secured by the personal obligations of the individuals composing the Board, and we would respectfully ask to be relieved from this responsibility.

The following calculation is submitted, showing the cost of keeping the insane for the past year.

The aggregate time of insane patients cared for being 3397 weeks, it will appear from the foregoing figures that the average cost of the maintenance of each insane patient was \$2.01 per week.

The keeper estimates the crop raised on farm as follows:-

Hay, 17 tons; Corn, 3 tons feed green; Oats, 5 tons; Beans, 10 bushes; Wheat, 1 ton; Turnips, 70 bush; Beets, 50 bush; Peas, 10 bush; Barley, 2 tons; Gooseberries, 2 bush; Potatoes, 450 bushels; Carrots, 45 bush; Cabbage, 314 heads; Mangels, 800 bush; Apples; about 30 bush.

Referring to our report of last year, in regard to Fire Escapes, we beg say, that the plans for wooden erections submitted to Government having proved unsatisfactory, the Commissioners subsequently agreed to erect two iron escapes, which received the sanction of the Government, and the contract for the construction of the same has been awarded to Mr. John Stewart, New Glasgow, for the sum of Fifteen hundred and Fifty Dollars. These escapes are to be finished and placed in position by the 31<sup>st</sup> of January 1891. The Commissioners are convinced that they will prove much more convenient and efficient than those previously determined upon.

The Commissioners regret having to record a vacancy on the Board by reason of the death of the late Daniel Shaw, which occurred on the 17<sup>th</sup> September, 1890. we take this opportunity of bearing testimony to the assiduity of the deceased, and to our high appreciation of his personal character.

The Commissioners beg further to report that we have almost reached the stage when the accommodation will require to be extended, or the Poor patients will have to be returned to their districts.

H.R. Munro, Esq. M.D. has been reappointed Medical Officer at the same salary as last year.

The contracts for supplies for 1891, have been awarded to the lowest tenderers as follows:-

Re: Asylum Commissioners Report 1890. P.S.

The aggregate time of all patients cared for in the Asylum in 1890 was 4628 weeks showing an average cost of \$1.83 per week, per patient for actual running expenses (as classified)

This appears to be an increase of 12 cents per week per patient as compared with 1889, caused by additional "interest" charges and other necessary expenses, outside *ordinary* maintenance.

The sum of \$9000 assessed for the Asylum in 1890 is yet to be paid to the Commissioners, the payments received from the County Treasurer in 1890 being for balance on previous assessments levied.

There is also a balance of \$1500 due the Commissioners from Assessments previous to 1890.
