MINUTES AND PROCEEDINGS Of the Municipal Council of Pictou County. APRIL SESSION, 1892.

First Day. Tuesday, April 19th, 1892.

Council met at 10 a.m., and was opened with prayer by the Warden. The Clerk called the roll.

The Warden read the semi-annual report of the Treasurer, and commented thereon. He also referred to the Geldert case and to the claim of the County against the Municipality of Cumberland for money expended for the support of a pauper lunatic. These matters were further discussed by Clrs. J.D. Fraser, J.D. McQueen, J.W. Fraser, W.S. Fraser, and Alex. Fraser.

The papers filed since the January meeting were distributed to the proper committees.

Clr. J.D. Fraser moved, seconded by Clr. A.J. McKay, that no petitions be received after 10 a.m. tomorrow. Carried.

A petition was received from the New Glasgow Electric Light Co., which upon motion was read by Mr. J.L. Jennison, the President of the Company, who, by leave, addressed the Council upon the matter. On motion the petition was referred to the Nominating Committee.

Clr. Collie read a memorial from the Board of Revision and Appeal respecting their remuneration and traveling expenses. On motion the memorial was received was discussed by Clrs. Thompson, J.D. Fraser, and the Warden. Clr. J.D. Fraser moved, seconded by Clr. Mitchell that the memorial be referred to the Finance Committee. The motion was discussed by Clrs. Collie, McQueen, Thompson, and J.D. Fraser, and passed.

On motion Daniel Fraser addressed the Council, advocating the laying out of a road from McNaughton's W.B. East River, to Ferrona, and thence to Eureka. The matter was referred to the Road and Bridge Committee.

Clr. Ferguson inquired whether the Municipality can compel a person to hold two offices at the same time.

On motion of Clr. A.J. McKay seconded by Clr. Murray it was resolved that no private Statute Labour petitions be received at this half yearly meeting.

On motion the Committees proceeded to work, and at noon the Council adjourned till 2 p.m.

Afternoon Session.

Council met at 2 p.m. The papers filed since the forenoon were distributed to the proper Committees.

The Nominating Committee submitted the following Report.

Report of the Nominating Committee To the Municipal Council of Pictou County.

Your Committee on Nominations beg leave to report as follows -:

That we have examined the memorial of the New Glasgow Electric Company, Limited, read in open Council today and that we recommend that the following persons, namely- John Murray, James W. Fraser, and John D. McQueen, Councillors, be a Committee to deal with the matters referred to in the memorial above mentioned, the proposed Street Railway, said Committee to have full power, with the said Company, to locate the proposed Street Railway on the Street through the village of Trenton to the New Glasgow town limits, and to approve and direct the laying of said Street Railway on the Street through the village of Trenton to the laying of said Street Railway, and switches in connection therewith, and do all such other things as may be necessary in the premises, and to report at the next annual meeting of this Council.

Court House, Pictou, April 19th, 1892 H.S. Fraser Alex. J. McKay Geo. M. McKay Nominating Committee

The Report was received and adopted.

The Committees proceeded to work until 5.15 p.m., at which hour the Council reassembled. Clr. A.J. McKay proposed that the annual visit to the Asylum be made tomorrow afternoon. The matter was discussed by Clrs. H.S. Fraser, J.D. Fraser, Smith, J.W. Fraser, the Warden, Mitchell, and Murray. On motion of Clr. J.D. Fraser, seconded by Clr. Thompson, it was resolved that the Provincial Road Grant be expended this year through supervisors.

A general discussion ensued upon the Geldert case, the bushing of ice on the different harbours in the county, and other matters affecting the Municipality, and at 6 p.m. the Council adjourned to meet at 10 a.m. tomorrow.

Second Day. April 20th Forenoon Session.

Council met at 10 a.m. The papers filed since yesterday were distributed to the proper committees.

Clr. Dewar brought up the matter of the petition of Ann Sutherland for aid in fencing a road, being the same petition was presented last winter and moved that the aid asked for be granted. On motion of Clr. J.D. Fraser the discussion was adjourned until the report of the Road and Bridge Committee should be received.

A petition asking for aid to repair a wharf at Big Island, Merigomish, was read by the clerk, and on motion was referred to the Finance Committee.

Road Board No. 3 reported as follows:-

Report of Road Board No. 3

To the Warden and Councillors of the Municipality of Pictou County, April Term, 1892.

We the undersigned, your committee duly authorized and appointed to inspect railway crossings on the main road, East River, met with Mr. Robert Chambers at Bridgeville. We found the road at crossing rather steep as the railroad was excavated 4 feet below the original grade of the main road.

Therefore your committee instructed Mr. Chambers to take more of a slope out of the road bed, and to continue it some rods further up the hill, and widen the road by cutting away the bank on the upper side, and open a ditch on the lower side of the road.

Your committee instructed Mr. Chambers to open ditches on an alteration of the road at Samuel Fraser's, and raise the centre of the road, and also to fill each side of the Vale road at the iron bridge near Springville. All of which Mr. Chambers agreed to perform to the satisfaction of the supervisor.

Your committee met with Mr. Sjostedt at his works Grant's and found an alteration on the main road. We advised Mr. Sjostedt to move a small building and extend the alteration some few rods further up to a place pointed out, and to cut away a point of the back of the road the crossing and also widen a narrow place on the road on the bank of the river, and put a fence on it with posts and rails. All of which Mr. Sjosted agreed to perform to the satisfaction of the supervisor of road board, No. 3.

Jas. T. Thompson John Murray W. Scott Fraser

On motion the report was received and adopted.

A resolution respecting the petition of W. S. Fraser, Lorne, for leave to lay water pipes along the highway, was moved by Clr. Murray, seconded by Clr. Munro. Consideration thereof was deferred till tomorrow morning.

Clr. J.D. Fraser moved, seconded by Clr. Alex. Fraser, that the annual subsidy to the Pictou Ferry Company for 1891 be paid. The resolution was discussed by Clrs. J.D. Fraser, Ferguson, Colin Fraser, W.S. Fraser, the Warden, Clr. J. W. Fraser, and was carried.

Clr. McIntosh read a memorial from the overseers of poor for sec. 10, which on motion was referred to the Committee on Poor.

Clr. Dewar gave notice that he would move tomorrow at 10 o'clock that the Council ask authority from the Legislature to borrow money for the repair of roads and bridges.

The committees proceeded to work and at 12.30 p.m. the Council adjourned until 10 a.m. tomorrow to enable the Councillors to visit the Asylum.

Third Day Forenoon Session April 21st.

Council met at 10 a.m. The minutes of the previous meeting were read and approved.

The resolution respecting the petition of W.S. Fraser introduced yesterday was by leave withdrawn, and the following resolution was moved by Clr. Thompson, and seconded by Clr. John D. McQueen.

Whereas W.S. Fraser of Lorne, polling section No. 17, petitioned this Council for permission to lay a small water pipe under the drain along the side of the highway, and whereas said petition was referred to the road board No. 3, which granted Mr. Fraser the privilege asked for subject to the approval and sanction of the supervisor of the road board No.3. Therefore resolved that this council has no objection for granting this privilege to W.S. Fraser subject to existing legislation.

Jas. T. Thompson John D. McQueen

The resolution passed.

The following resolution was moved by Councillor, J.D. Fraser, seconded by Clr. John D. McQueen, and passed.

Resolved that the order passed in January Term, A.D., 1891, regarding the bushing of ice by rescinded and the following order be substituted: Space between bushes shall not be more than ninety feet, and not nearer to each other than forty-five feet as in the discretion of the commissioners localities may require.

Clr. Thompson read the following report of the Assessment Committee.

Report of the Assessment Committee

Your Committee on Assessment beg leave to report as follows:-

That they have examined all petitions and all papers which came before us, and would recommend that the following persons be entitled to a refund of taxes.

Your Committee finds the polling section 23, in arrears for taxes due for three years previous to the year 1892 to the amount of \$557.22.

There are also several other sections with smaller amounts due, and we would recommend that the Treasurer notify the bondsmen of the several collectors from whom the taxes are due that they will be held responsible unless satisfactory returns are made.

On motion the report was received. On motion the report was read clause by clause. On the clause respecting the claims of Mrs. Sarah Fraser for compensation for fencing being read, Clr. W.S. Fraser moved, seconded by Clr. Alex. Fraser, that although the Council recognizes no liability, the petitioner paid the sum of \$18.75 upon proof that the fences have been properly built. The motion was discussed by Clrs. W.S. Fraser, J.W. Fraser, J.T. Thompson, Alex. Fraser, the Warden and Clr. J.D. McQueen. The motion was passed on a vote of 14 to 1.

On the clause referring to the streets at Trenton being read, Clr. Murray moved, seconded by Clr. J.W. Fraser, that the clause be not adopted but that the petition be granted, the changes asked for not to take effect till 1893. The motion was discussed by Clrs. Murray, J.W. Fraser, the Warden, J.D. Fraser, J.T. Thompson, W.S. Fraser, and passed. On motion the report was adopted as marked in the margin thereof, and the roads therein recommended to be disallowed were severally disallowed, and the precepts therein recommended to be issued were severally ordered to be issued.

The petition of Ann Sutherland for compensation for fencing was brought up for consideration. Clr. J.D. Fraser moved, seconded by Clr. Dewar, that the sum of \$15 be paid to Ann Sutherland for fencing upon proof that the fence has been properly built. The motion

was discussed by Clrs. Dewar, J.D. Fraser, Alex Fraser, Ferguson, and the Warden, and the motion passed.

Clr. J.W. Fraser moved, seconded by Clr. Murray, that a committee be appointed to inquire into the matter of the boundaries of polling sections 12 and 23, and report this afternoon.

The Nominating Committee presented the following report:-

We recommend that John D. Fraser, John D. McQueen, and John Murray be appointed a committee to investigate, find out and define the boundaries between sections No. 12 and 23 and report this afternoon session.

Afternoon Session

Council met at 2 p.m. The minutes of the previous session were read and approved. Clr. Alexander Fraser read the following

Report on the Bonus to the Stewiacke Valley and Landsdowne Railway. To the Municipal Council, Pictou County. April Term, A.D., 1892.

Your Committee appointed to the annual meeting of Council to enquire into and ascertain the legal liability of the said County in reference to the resolution passed in the January Term, 1891, in aid of the Stewiacke Valley and Landsdowne Railway Co, Limited, beg leave to report as follows:-

That in the January term of 1888 a resolution was passed in aid of said railway; see page 59, Proceedings of Municipal Council of the year 1888, granting the said Company a subsidy of \$500 per mile, but not exceeding in the whole the sum of \$8000, this subsidy or bonus to expire on the first day of July, 1891m unless said railway be opened for traffic and proof furnished to said Council on or before said first day of July, 1891.

We find in the January term of said Municipal Council 1891 a petition was presented to this council asking for an extension of the said term, in which said petition the sum of \$500.00 was not mentioned, but it was stated as follows: - "That a subsidy of eight thousand was granted by the Municipal Council of Pictou County in January term 1888 in aid of said company's railway." We find that a committee was appointed to consider the matter and report to the council then sitting. Said committee understood the said petition to ask merely an extension of the time fixed in 1888, the bonus subject to the same terms. We find, however, such is not the true nature of the resolution passed in the said January term 1891. Section 1, of the said resolution recommended that a sum of \$8000.00 be granted to said company, and Section 2 or said resolution states that said subsidy shall be paid to said company upon completion of said railway from the county line to Landsdowne. The distance between said points is only about four miles, and extending the term for completing said railway between said points to the first day of February, A.D., 1895, thus in effect changing

the subsidy from \$500.00 per mile to about \$2000.00 per mile. We also find that the Local Legislature passed an act on the 19th of May 1891, empowering this Municipal Council to vote a specified sum not exceeding eight thousand dollars to aid in the construction of said railway.

Your committee would therefore, recommend that application be made to the Local Legislature for an amendment to Chap. 98 of the acts of 1891 by sticking out the words "a specific sum of money not exceeding \$8000.00" in the second and third lines in the first section thereof, and substituting the words "a subsidy of \$500.00 per mile, not exceeding in all the sum of \$8000.00."

All of which is respectfully submitted. Court House, Pictou, April 21st, 1892. The report on motion was received and adopted. Clr. A.J. McIntosh read the following:-

Clr. McKay read the following.

Report of the Statute Labour Committee. To the Municipal Council of Pictou County, April Term, 1892.

Your Committee on Highway Labour beg to report as follows:-

That the following road returns have been received by the Clerk since the January meeting of the Council, viz:- In Sec. 5, no. 117, in Sec.6, 159, in Sec. 9 no. 223, in Sec. 10, 261, Sec. 13, Nos. 318 and 325. Sec 15, 378. Sec. 16, 397. Sec. 21, 526.
