# Municipal Council of Pictou County. JANUARY SESSION, 1892.

Tuesday, Jan. 12, 1892.

The Council met at 10 a.m. All the Councillors were present. The Warden opened with prayer.

Clr. H.S. Fraser asked leave to resign his position on the Nominating Committee, but in accordance with the general wish of the Council withdrew his request.

The Warden reviewed the business of the Municipality said the last meeting of Council, referring specially to the Geldert case, the case of Dunn against the County of Pictou, the legislation dealing with the Market and the old Jail, and the erection of a new polling Section, No. 26, out of Sections 2 and 3.

Moved in amendment by Clr. A.J. McKay, seconded by Clr. J. Kitchin, that Thursday the 14<sup>th</sup>, at 2 p.m. be the latest date. The motion was carried on division.

The papers on file were distributed to the proper Committees.

On motion of Clr. Dewar, the report of D.W. McDonald on the road from the railway crossing at Barney's River to Menzie's Grant, was read in open Council.

The Warden read the Treasurer's Annual Report for 1891.

The Committees proceeded to work and on motion the Council adjourned until 2 p.m.

#### Afternoon Session.

Council met at 2 p.m.

The minutes of the previous meeting were read and approved.

The papers filed since the morning were distributed to the proper Committees.

On motion the Committees proceed to work, and the Council adjourned until 10 a.m. tomorrow.

Wednesday, Jan. 13<sup>th</sup> Forenoon Session.

Council met at 10 a.m. The minutes of the previous meeting were read and approved. The papers filed since previous meeting were distributed to the proper Committees.

At the request of Clr. Dewar, the Act passes last winter respecting the Pictou Market, was read by the Clerk.

The opinions of Justices Weatherbe and Townshend in the Geldert case were read in open Council.

The Committees proceeded to work, and at 12.30 the Council adjourned to meet at 2 p.m.

Afternoon Session.

The Council met at 2 p.m. The minutes of the previous meeting were read and approved. The papers filed since last meeting were distributed to the proper Committees.

The Memorial of the Pictou Steam Ferry Company was read in open Council. Clr. Ferguson said the new boat was a good one for the service, and so far as he knew the facts set out in the Memorial were correct; but the service so far had not been satisfactory. The boat is not run to connect with trains on the Pictou side.

A letter from Sec. 18, complaining of the assessment of that Section was on motion of Clr. Wm. McLeod, read by the Clerk. A general discussion followed, and the matter dropped.

The Committees proceeded to work and at 5 p.m. the Council adjourned to meet at 10 p.m. tomorrow.

Thursday, Jan. 14<sup>th</sup> Forenoon Session.

Council met at 10 a.m. The minutes of the previous meeting were read and approved. The papers filed since last meeting were distributed to the proper Committees.

Clr. Colin Fraser moved the following resolution, seconded by Clr. James Campbell, Chairman of Road Board No. 2.

"Resolved that the bridge over West River at Watervale, in Polling Section No. 9 of Pictou County, be placed under the provisions of the Bridge Act."

The resolution passed.

A communication from the New Glasgow Coal, Iron, and Railway Company, respecting changes in the highways along which their railway runs was on motion referred to the Road and Bridge Committee.

On motion of Clr. J.D. Fraser, it was resolved that the Town Councils of Pictou, New Glasgow, and Stellarton be notified to meet with this Council at 2 p.m. on Tuesday, the 19<sup>th</sup> instead to adjust the proportions of county rates to be paid by said Towns.

The Committees proceeded to work and at 1 p.m. the Council adjourned to meet at 2 p.m.

Afternoon Session.

Council met at 2 p.m. The minutes of the previous meeting were read and approved. The papers filed since the last meeting were distributed to the proper Committees.

Clr. Thompson drew attention to the requirements of the Act respecting Boards of Health. Clr. Murray and the Warden also spoke on the subject and the matter was referred to the Nominating Committee.

The Report was received and adopted.

Clr. J.W. Fraser moved the following Resolution, seconded by Clr. Murray, Chairman of Road Board No. 3.

"Resolved that the Bridge across the Big Gut at Granton, Sec.12, of Pictou County, be placed under the provisions of the Bridge Act."

The resolution passed.

Clr. McQueen called attention to the expenditure for the Jailor and the jail and Court House at New Glasgow, and pointed out that no such expenditures were made in Pictou or Stellarton, Then Warden and Clrs. W.S. Fraser, J.W. Fraser, Dewar, Kitchin, J.D. Fraser, and Ferguson discussed the question, and the matter was referred to the Committee appointed to adjust the proportion of County Rates to be paid by the Towns.

Clr. Kitchin drew attention to a claim of the County against the County of Cumberland for the expenses of an insane pauper in the Asylum at Stellarton. After some discussion, the matter was referred to the Warden.

Clr. Alex. Fraser said that the Town of Pictou had taken gravel last summer off the side of a road outside of the Town limits and that the excavation had not been properly fenced.

Clr. Dewar mentioned the case of a road limit partly in Sec. 19, and partly in Sec. 20, and expressed doubts as to whether residents in one Section could be compelled to perform statute labor in another.

The Committees proceeded to work, and at 5 p.m. the Council adjourned to meet at 10 a.m. tomorrow.

Friday, Jany.15<sup>th</sup>. Forenoon Session.

Council met at 10 a.m.

The minutes of the previous meeting were read and approved. The papers filed since last meeting were read and distributed to the proper Committees.

A petition from some ratepayers of Sec. 14 to approve of a bill to add a part of that Section to Sec.24 was on motion of Clr. J.D. Fraser received, and ordered to be laid on the table.

The following resolutions were moved by Clr. John D. Fraser and seconded by Clr. Mitchell, Chairman of Road Board No.4.

"*Resolved* that the bridge spanning East French River, Piedmont Valley Road, District No. 21, be placed under the provisions of the Bridge Act."

"*Resolved* that the Bridge on the Garden Rover near the Garden Church, District No. 22, be placed under the provisions of the Bridge Act."

Both resolutions passed.

The Warden referred to the old Market in the Town of Pictou, explaining the present position of affairs, and asking for an expression of opinion on the subject. Clrs. A.J. McKay, H.S. Fraser, J.D. Fraser, J.W. Fraser, Alex. Fraser, Kitchin, Ferguson, McQueen, Campbell, and Colin Fraser, discussed the matter, and it was referred to the Warden to report as soon as possible this Session.

The Committees proceeded to work and at 1 o'clock the Council adjourned until 2 p.m.

Afternoon Session.

Council met at 2 p.m.

The minutes at the previous meeting were read and approved. The papers filed since last meeting were distributed to the proper Committees.

Clr. Alex. Fraser complained of nuisances committed every year in Sec.2, by residents of the Town of Pictou depositing carcasses of animals outside the Town limits. After some discussion, it was resolved that each Councillor submit to the Nominating Committee a sufficient list of names to form a Board of Health for his District, and the name of a proper person to be Sanitary Inspector in each District.

The Committees proceeded to work and at 5 p.m. the Council adjourned to meet at 10 a.m. tomorrow.

Saturday, Jany.16<sup>th</sup> Forenoon Session.

Council met at 10 a.m.

The minutes of the previous meeting were read and approved. The papers filed since last meeting were distributed to the proper Committees.

A letter from Messrs. Borden, Ritchie & Co., was read, stating that Mr. Finlay, the English counsel consulted in the Geldert case, advised an appeal.

The Warden stated the results of a meeting he had last night with representatives of the Pictou Town Council and the Agricultural Society, respecting the old Market. Some discussion followed, and the matter was referred to the Warden and the Committee on Public Property.

Clr. J.W. Fraser called attention to the fact that a part of the road from New Glasgow to Westville has sunk several feet, owing to mining operations of one of the collieries.

Clr. A.J. McKay read the Report of the Road and Bridge Committee. On motion the Report was received. The first clause was read, and on motion of Clr. Munro, seconded by Clr. J.D. Fraser, it was ordered that the extension of time asked for be granted, and that the precept be returned to the Commissioners. On motion of Clr. J.D. Fraser, seconded by Clr. Kitchin that portion of the Report dealing confirmation of roads was adopted and the roads, therein recommended to be confirmed were severally confirmed, and the roads therein recommended to be disallowed, were severally disallowed. On motion the balance of the Report was adopted, and the precepts therein recommend to be issued were severally ordered to be issued.

#### Report of the Committee on Poor.

To the Municipal Council of Pictou, January Term, 1892.

Your Committee on Poor beg leave to report as follows, viz:-

That the returns from the several Poor Districts of the County have been before them and examined.

That in many cases those returns have been carelessly or partly filled out causing much trouble and labour to your Committee, and we regret that the repeated recommendations of your Committee on this matter have been as repeatedly disregarded.

That many of the returns have been late in coming to hand thereby causing delay.

That by a comparison of this year's report with that of last year it will be seen that the number of poor in the County has increases thirteen.; that the average cost of maintenance has increased three dollars and eighty six cents; and that the total amount to be assessed is \$355.62 less than last year. Hereto we attach an abstract of returns of Overseers of Poor for the several Districts. Respectfully submitted.

On motion the Report was received and adopted.

Clr. A.J. McKay proposed the passing of a By-law to impose a license on peddlers and transient traders. Clr. J.D. Fraser moved, seconded by Clr. A.J. McKay that the License Committee be instructed to draft a By-Law on the subject and report this term.

The Warden introduced the subject of the action of G.J. Geldert against the Municipality and the Appeal taken thereon to the Privy Council. The matter was discussed by Clrs. J.D. Fraser, Geo. M. McKay, James W. Fraser, John D. McQueen,

James T. Thompson, Jno. Smith, Jas. Mitchell, Colin Fraser, Alex. Fraser, John Ferguson, and James Campbell. Clr. J.D. Fraser moved the following resolution, seconded by Clr. A.J. McKay.

"Resolved that the matter of the Geldert Case be left with a Committee, together with the Warden and Clerk, to take such steps as may be necessary in the meantime; and to consider offers for settlement, if any, without prejudice, and also to see what aid towards paying the cost of the Appeal can be obtained from the other Municipalities in the Province, and the Local Government.

The resolution passed.

Clr. W.S. Fraser moved, seconded by Clr.R. McLeod.

"Whereas the Bridge on the road leading from Plymouth to the Town of Stellarton already placed under the provisions of the Bridge Act, is in a dangerous condition."

"Therefore resolved, that the Council recommend the Provincial Authorities to give this matter immediate attention and have this bridge rebuilt so as to insure the safety of the traveling public."

The resolution, after discussion by the Clrs. Murray, Alex. Fraser, W.S. Fraser, J.D. Fraser, J.T. Thompson, and Colin Fraser, was carried.

The Committees proceeded to work and at one o'clock the Council adjourned till 2 p.m.

Afternoon Session.

The Council met at 2 p.m. The minutes of the previous meeting were read and approved.

A report from the Supervisor of Road Board No. 1, respecting gravel pits dug by the Town of Pictou on the side of the road near Barry's Mill Dam was read, and on motion of Clr. J.D. Fraser, it was ordered that a copy of the Report be sent to the Town Council of Pictou with a request to attend to the matter.

The Committees proceeded to work and at 5 p.m. the Council adjourned to meet at 10 a.m. tomorrow.

Wednesday, Jan. 20<sup>th</sup>. Forenoon Session.

Council met at 10 a.m. The minutes of the previous meeting were read and approved.

The Warden read a reply from Lord Stanley to the resolution respecting the death of the Duke of Clarence.

Clr. G.E. Munro read the following:

#### Reports on Horn's Brook Railway Crossing.

Your Committee appointed to look after the Railway Crossing at Horn's Bridge beg leave to report that the Railway Department has done the work in a very satisfactory manner, and made a good road. But your Committee think they should have made a more level crossing for twenty feet on each side of the track.

Signed, G.E. Munro James W. Fraser John Murray

The Report was received and adopted and the Committee re-appointed.

Clr. Kitchin brought up the question of lunatics who are a charge upon the County, and mentioned a case at River John. Clr. Alex. Fraser mentioned several cases in Section 2. A general discussion followed and the matter was referred to the Committee on Law Amendments.

Clr. A.J. McKay read the following:

"Whereas it is desirable that a market building be erected on the old Market Square in the Town of Pictou, and a country market thereon.

And whereas by Chapter 100, of the acts of the Legislature of Nova Scotia passed in 1891, the Municipality of Pictou County is authorized to convey said Market Square to the Town of Pictou upon condition that the said Town shall erect a Market Building and Market thereon, subject to such terms and regulations as may be agreed on by the Warden of the County and the Mayor of said Town.

Be it therefore resolved that the sum of \$1000 be assessed upon the Municipality of the County of Pictou outside of the incorporated Towns; namely the sum of \$500 in the year 1893, and the sum of \$500 in the year 1894, for the erection of a Market house in the Town of Pictou for the purpose aforesaid, provided the said Town shall erect upon said square a suitable market building costing not less that two thousand five hundred dollars exclusive of the value of the site, and shall erect the same under the supervision and to the approval of the Warden of the Municipality and of such persons as he may select as Inspectors; but no part of the said sum shall be paid to the said Town unless the said town shall duly fulfill and perform all the conditions specified in the second Section of said Act, and shall accept the conveyance mentioned therein, in accordance with the meaning of said Act; and provided also that if any rights or privileges pertaining to trade within the town now exercised by persons residing within the bounds of the Municipality shall hereafter be restricted or interfered with by the Town or Town Council or at their instance then the town shall repay the said sum o the Municipality with interest at 4 per cent."

The resolution was seconded by Clr. Alex. Fraser, and discussed by Clrs. Colin Fraser, John Ferguson, John D. McQueen, the Warden, John D. Fraser, and James Kitchin. On motion the resolution was amended by providing for the assessment of the amount in 1893 and 1894, instead of in 1892 and 1893. The matter was further discussed by Clrs. J.W. Fraser, and J.D. Fraser and passed, subject in all respects to the Act passed last winter respecting the Pictou Market.

On motion of Clr. Kitchin, seconded by Clr. A.J. McKay it was ordered that Revisal Section 2, hereafter include Polling Sections 3, 4 and 26.

Moved by Clr. Kitchin, seconded by Clr. Alex. Fraser, that the Legislature be requested to pass an Act to legalize the Assessment and Collector's Rolls as made out for the old Sections 2 and 3 for 1892.

Clr. Thompson read the following:

To the Municipal Council January Term 1892.

Your Committee on Assessment beg leave to report as follows:

The Report of the Board of Revision and Appeal passed.

Petition of Alex. McKenzie, Section 18, praying for exemption from taxation for the year 1892. Granted.

Ordered that 23 cents be returned to Angus McKinnon, collector for Section No. 16. The same being overpaid by him.

Ordered that the sum of \$5.34 be returned to Adam Campbell, collector of Section 6, the same being overpaid by him.

Ordered that the sum of \$2.97 be retained by the Treasurer out of commissions on County rates now about to be paid in to by E. Cameron and refunded to A.S. McKenzie Sec. 23.

Petition Walter Patterson, Section 19, praying for a refund of taxes, not granted. Should have come before B.R. and A. of 1891.

Petition of Alex and Murdock McInnis. Not granted.

Petition of Jane Matheson for a refund of taxes. Not granted as we think \$400 was exempted by Assessors.

Petition of D.S. Fraser for a refund of &17.91. Not granted.

Petition of Thomas Young, Sec.6. referred further to Board of Revision and Appeal for January 1892.

Petition of John D. Cameron asking for a refund of \$4.27. Granted.

Ordered that the Overseers of Poor refund said John D. Cameron, the sum of 44 cents.

Petition of Mrs. Mary B. McLellan asking for exemption from taxation for year 1892 on property assessed in name of Dan McLellan, Section 17. Granted.

Petition Peter Anderson of Section 23. Not granted.

Petition of Hugh McDonald of Section 21. Not granted.

Petition of D.W. McDonald, section 17, deferred to April term.

Petition of W.G. Beach, Section 13; deferred to April Term.

Petition of David McLean, Sec. 8; deferred to April Term.

There is still due to the County the amount of \$175.53 from E. Cameron,

Collector of Section 13, for year 1890. Bondsmen hold themselves responsible and it is expected it will be paid in a few days.

The Report was received and was discussed by Clrs. Kitchin, McQueen, Thompson, W.S. Fraser, J.D. Fraser, Alex. Fraser, Mitchell, A.J. McKay, and the Warden. On motion the Report was adopted. On motion the Treasurer was directed to notify the sureties of McIvor, Collector for Sec. 2. of the settlement of his case. Clr. Smith read the following.

#### Report of the Committee on Public Property

Court House, Pictou, January Term, 1892 To the Warden and Councillors of the Municipality of Pictou Co.

GENTLEMEN,- Your Committee on Public Property, after having made their investigations for the year, beg leave to report that we have visited the difference public buildings owned by this county, and find them generally in a satisfactory condition. First on visiting the Asylum, we found it in very good order, the building being well painted and cleaned, both inside and out. Since the last meeting of Council, the Commissioners have had a building erected on the farm, to be used as a root cellar; this we approve of, as in our opinion it was something much required. The only matter in which we would offer a suggestion is, that the ventilation of the building in which the patients are confined, might be a little better than it is at present.

Second,- The Jail is in every respect, so far as we can see, satisfactory to the county, and creditable to the Sheriff and our jailor. It has been painted in a thorough manner by the prisoners confined therein, at a very slight cost to us, and is now in a condition that we may point to it as an institution that is a credit to this county.

Third,- That the County Building in which are situated the offices of Clerk, Treasurer, and others, we find in a satisfactory condition, only requiring some slight repairs. That will be attended to at once by the Commissioners of Public property.

Fourth. - The Jail at Westville requires some painting and repairs which will be attended to by the Commissioners.

Fifth. - The Sheriff of this County has made your Committee an offer of fifty dollars for the stone wall around the old jail lot, and this we would recommend for your consideration.

On motion the Report was received and was discussed by Clrs. Smith, Ferguson, Kitchin, J.W. Fraser, and the Warden, and on motion the Report was laid on the table till tomorrow at 10.30 a.m.

Clr. Ferguson read the following.

## Report of the Committee on Licenses. Court House, Pictou, Jany. Term, 1892.

To the Warden and Municipal Council:

1. We your Committee on License beg to report that we have examined the returns of Mr. Wm. Smith, one of the inspectors of License under the Scott Act for the County. We find that he collected fines amounting to \$168.15 during last year; that he has also collected from old fines the sum of \$110. Balance due the County at last Annual report was \$22.18, making in all \$300.33. We find he paid out in Magistrates courts as costs the sum of \$151.86; Attorneys and others fees \$128.25, total costs \$280.11, which shows

a balance in the Inspector's hands of \$20.22, within \$2.00 of the same balance of last year. He reports a fine against John Evans of \$50.00 and costs of appeal \$19.72, which he says will be collected before very long.

We also find another fine against John Evans for \$50.00 and costs, and another fine against Mrs. E Evans for \$100, which when collected will be to the County's credit.

2. We have also examined the returns of Mr. Thomas Madden of Westville, another Inspector under the Scott Act. We find that has collected from fines the sum of \$450, that he has paid out in Magistrate courts, Attorneys fees, \$C., the sum of \$458.18, leaving a balance due Mr. Madden of \$8.68. There is a fine of \$50.00 and costs to which he expects to get before many days. There is also another fine indisposed of \$50.00, which he expects to collect.

Mr. Madden has tried thirty-nine suits and won twenty-five cases. He states that he has closed ten liquor saloons. There are four petitions or recommendations for the re-appointment of Mr. Madden to the office of Inspector of License.

- 3. In view of the fact that these Inspectors have received no remuneration for their services, we would recommend that Mr. Smith and Mr. Madden be allowed to retain the sum of \$50.00 each out of the first moneys coming into their hands from fines.
- 4. We recommend that Mr. William Smith of New Glasgow, Mr. Thomas Madden of Westville, and Mr. Robt. Sutherland of River John be re-appointed Inspectors under the Scott Act.
- 5. We further recommend that peddlers and hawkers of goods, not freeholders, pay an annual license fee as follows:-

And that any person found violating these rules be fined double the amount of the license fee. That the Clerk and Warden be appointed a Committee to frame a suitable by-law on this matter and have it submitted to the Governor in Council for ratification at its first sitting. We would also recommend that the parties named as persons to distribute Statute Labor Instructions in their several Polling Sections to Overseers of roads, be the issuers of those licenses; that the issuers of those licenses be allowed to retain ten per cent of the amount collected; that the issuers of those licenses make a semi-annual return to the Council.

6. There was a petition from Mr. Alex. Fraser, asking for an Auctioneer's license in this Municipality, but we think the prayer of the petition should be deferred until the by-law regulating Auctioneers and Peddlers be obtained.

J.R. Collie, John Ferguson Jas. W. Fraser Com. on Licenses On motion, the Report was received. On motion at 1 oc'clock, ,the Council adjourned till 2 p.m.

#### Afternoon Session.

Council met at 2 p.m. The mintues of the previous meeting were read and approved.

The Warden read the claim of A. Muirhead for damages resulting from the construction by the Government of the Saw Mill Bridge, and stated that he intended to meet with the claimant this afternoon, and inspect the property alleged to be damaged.

On motion the Report of the Committee on Licenses was taken up to be read clause by clause. On motion the first clause was adopted. On motion the 2<sup>nd</sup> clause was adopted. On motion the 3<sup>rd</sup> clause was adopted. The 4<sup>th</sup> clause was on motion referred to the Nominating Committee. On motion, the 5<sup>th</sup> clause was amended by substituting the words "ratepayers of the Municipality" for the word "freeholders," and by providing that prined forms of license be prepared by the Clerk and sent to the Distributers of Statute Labor Instructions. On motion the clause as amended was adopted. On motion, the 6<sup>th</sup> clause was adopted.

Clr. A.J. McKay proposed that an arbitrator be appointed to meet with arbitrators to be appointed by the Towns, to settle the proportions of County Rates to be paid by the Towns in 1893. After some discussion, the Nominating Committee was instructed to name an arbitration Committee and an Arbitrator.

On motion at 5 p.m., the Council adjourned to meet at 7 p.m.

#### Evening Session.

The Council met at 7 p.m. The minutes of the previous meeting were read and approved.

The Report of the Committee on Law Amendments was read. On motion the Report was received and after discussions by Clrs. J.W. Fraser, John D. Fraser, Alex. Fraser, Ferguson, and Rodk. McKay, was adopted. The following is the:

## Report of Committee on Law Amendments.

To the Municipal Council of the County of Pictou, January Term, 1892.

Your Committee on Law Amedments be leave to report as follows:

1<sup>st</sup>. That (a.) Chap. 46 Rev. Statutes be amended as follows:-

That Municipalities shall in no case be liable for damages for accidents that may occur by trucking, riding, driving or walking on the highway, except neglect can be shown on the part of the official required to keep the highway or bridge in repair, and the Municipality shall in no case be liable for damages for accidents when the road bed is of the width of fourteen feet free from obstructions.

2<sup>nd</sup>. The municipality shall in no case be liable unless actual notice be given to the Councillor of the District or the Supervisor of the Road Board of the defect, for at least ten days before the injury.

- 3<sup>rd</sup>. The Municipality shall in no case be liable unless notice has been given by a ratepayer under Section 14 of Chap. 47 of the Revised Statutes as amended by Chap.53 of the Acts fo 1889, and by Chap.25 of the Acts of 1891; nor shall the Municipality in any case be liable if after such notice the provisions of said Section and amendments shall have been carried out in so far as the same may legally be done.
- 4<sup>th</sup>. Where a road or bridge becomes unsafe or impassable in the judgment of the Road Board and no means are available for the purpose of repairing the same the Road Board may order the Supervisor to close said road or bridge by fencing and to post notices at or near the vicinity stating that said road or bridge has been closed; and after such road or bridge has been closed and notices posted as aforesaid, all persons using said road or bridge or travelling over the same shall do so at their own risk and the Municipality shall not be liable for any inury resulting from any defect in said road or bridge.
- 5<sup>th</sup>. (b) Your Committee recommends that Section 15, Chap. 47, 5<sup>th</sup> series be amended by substituting the sum of 80c. instead of 50c. for each day's labour which he is liable to perform.

That Section 4, Chap. 47, 5<sup>th</sup> Series shall be amended by inserting after the word "labour" in line 3, the words "unless a son of the owner liable to perform Statute labour resides on the same property, in which case the owner shall be liable in accordance with the scale in Section 3.

That Section 8, Chap. 56, be amended as follows:

The Municipal Council may appoint more than one presiding officer in each Polling District and may fix the place where the poll shall be taken by each presiding officer in cases where more than one persiding officer shall be appointed in any Polling Section. The Council shall have power to make all necessary regulations for the counting of ballots and declaring the results of the poll.

That Chap, 45, 5<sup>th</sup> Series be amended as follows:

That Chap. 45, Series be amended as follows: - Before entering upon lands required for the construction of a new road or the alteration of an old road, instead of tendering to the owner the amount of compensation allowed, it shall be sufficient to provide the Treasurer with the necessary funds and to serve the owner with a notice that the funds are deposited with the Treasurer subject to the order of such owner. Notice shall be signed by the Municipal Clerk.

That whenever it shall be necessary in constructing; altering or repairing a highway to divert a water course, the damage occasioned thereby to any persons or property shall be ascertained by appraisers in the same manner as provided in acquiring lands for highways under Chap. 45 of the Revised Statutes, except that no petition from ratepayers shall be required, but the Council shall order the precept to be issued of its own motion.

Where errors or omissions have been made or changes are required in the Assessment Rolls between the posting of the revised Assessment Rolls and the collection

of the rates the Clerk shall be authorized to make such corrections on the order of the Assessors of the districts where the property is situate.

That the Act relating to the Harmless Insane Asylum be amended by granting power to the Wardens of Municipalities to transfer real estate of the inmates of said Asylum.

That the Assessment Act be so amended that no taxpayer shall have the benefit of the Insolvent Debtors Act.

That the County Incorporation Act be so amended that in no future no bonus or subsidy be granted by any Municipality to any body corporate except by the vote of the electors of said Municipality.

All of which is respectfully submitted.

By dividing this amount by 3364 weeks, the cost per head per week for the Insane appears to be \$2.21. But this is not strictly accurate as a per capita statement as the Council seems to have recognized at their last Jany. Term. We merely introduce it for the purpose of comparison with former years.

We also find that the total cost of food for the past year, including the produce of the farm as well as soap and drugs, amounted to \$5037.38, or about \$1.12 per head weekly.

In a note appended in the Minutes of Council to our Report for 1890, it was stated that the per capita cost of all patients in 1890 was \$1.83 (or more accurately \$1.84) per week against \$2.02 in 1891. In explanation of this increase it must be noted that there were some abnormal expenditures last year, such as repairs and painting of the buildings, and the purchase of a new wagon, which, however, we are not justified in classing as permanent additions. There has also been an increase in the charge of interest, partly because of our increased debt and partly because the County money was held back till very late in the year. These two items account for \$593.69 which, when deducted, reduce the cost per head to slightly under \$1.89.

The Fire Escapes referred to in former Reports, were erected last year, and in addition to their security to life in the event of a fire, they serve as airing places for patients in suitable weather.

Your auditors beg leave to report that they have examined the accounts submitted to them and find that many of them have not the necessary vouchers notwithstanding the published recommendation of preceding Committees.

They have also examined the books of the Treasurer and the books and papers of the Secretary of the Commissioners of the County Asylum and found them correct and very carefully kept.

We recommend that the \$2765.40 for "Grand Jury Presentments" appear no longer as a liability and that any payments made by the Treasurer on that account be charges to "Contingent account".

By dividing this amount by 3364 weeks, the cost per head per week for the Insane appears to be \$2.21. But this is not strictly accurate as a per capita statement as the

Council seems to have recognized at their last Jany. Term. We merely introduce it for the purpose of comparison with former years.

We also find that the total cost of food for the past year, including the produce of the farm as well as soap and drugs, amounted to \$5037.38, or about \$1.12 per head weekly.

In a note appended in the Minutes of Council to our Report for 1890, it was stated that the per capita cost of all patients in 1890 was \$1.83 (or more accurately \$1.84) per week against \$2.02 in 1891. In explanation of this increase it must be noted that there were some abnormal expenditures last year, such as repairs and painting of the buildings, and the purchase of a new wagon, which, however, we are not justified in classing as permanent additions. There has also been an increase in the charge of interest, partly because of our increased debt and partly because the County money was held back till very late in the year. These two items account for \$593.69 which, when deducted, reduce the cost per head to slightly under \$1.89.

The Fire Escapes referred to in former Reports, were erected last year, and in addition to their security to life in the event of a fire, they serve as airing places for patients in suitable weather.

A root house has also been constructed, and the Asylum has been painted outside, The keeper estimates the crop raised on the farm in 1891 as follows: Hay, 17 tons; green straw, 12 tons; potatoes, 200 bushels; beets, 50 bushels; cabbage, 127 heads; beans, 10 bushels; peas, 1½ bushels; mangles, 600 bushels, turnips, 30 bushels.
